Note: The 2002 NFP has been reduced by \$8,244.85 as 02-14 did not use these funds. The 2003, 2004, 2005 & 2006 "NFP" dollar amounts include the four annual exceptional grant awards of \$600,000 for the Lively Arts Center, Inc. by the County Council on October 16, 2003. The 2004 "NFP" amount was revised in March 2005 due to a return of \$90,720, grant 04-21, by the Pioneer Settlement for the Creative Arts. On March 10, 2005, the County Council re-directed the funds to the 2005 project awards. On March 17, 2006, County Council provided \$186,139 from the General Fund and also utilized \$100,000 from ECHO Reserve to support awards. **CANCELLED JAN 2007 - DBCC project award 05-07, NFP totals reduced by \$600,000 in years 2005 and 2006.** The 2005 and 2006 "County of Volusia" dollar amount does not include the annual allocation of \$1,000,000 to the County's Trails Master Plan approved by the County Council on June 3, 2004. 2008 includes \$208,048 of a 2007 Exceptional Award to DBC Southeast Museum and a 2008 Exceptional Award to the Ocean Center of \$3 million.
