- P.J. WARNER,
- 3 was called as a witness and, having first been
- 4 duly sworn, testified as follows:
- 5 BY MR. KANEY:
- 6 Q. Good morning, Mr. Warner.
- 7 A. Good morning.
- 8 Q. Do you go by P.J.?
- 9 A. P.J. My real name's Harold.
- 10 Q. Harold?
- 11 A. Harold Warner, believe it or not.
- 12 Q. How do you get P.J. out of that?
- 13 A. It's been with me forever. My dad had a nickname
- 14 that started -- it was Pill. My dad was Pill.
- 15 Q. Pill.
- 16 A. I was raised in the country in Maryland, and --
- 17 Q. So you're Pill, Junior?
- 18 A. I'm Pill, Junior. Because I'm Harold, Junior, so
- 19 I'm Pill, Junior. And if I have a couple of beers in me, I
- 20 could tell you a couple of other stories, but that's the
- 21 real story. Actually, I graduated from high school, they
- 22 put P.J. on the diploma. Almost every -- and I changed my
- 23 name legally in Florida for my real estate license to
- 24 advertise as P.J. So I go by Harold -- P.J. Warner is
- 25 legally my name for FREC, Florida Real Estate Commission,

- 1 because you have to have your real name, so I had to put
- 2 P.J. as my given -- you know, as a name, so.
- Q. Well, it's a nice sounding southern -- P.J., it's
- 4 easy to say.
- 5 A. You'll buy real estate from a P.J. quicker than
- 6 you will a Harold.
- 7 Q. Well, P.J., where are you employed?
- 8 A. RE/MAX Signature.
- 9 Q. Have you previously been employed by Waverly
- 10 Media?
- 11 A. I have my license -- no, not by Waverly Media. I
- 12 had my license hung for two and-a-half years at Waverly Real
- 13 Estate. A mistake.
- 14 Q. And why do you say that?
- 15 A. Well, how it all happened was, I was always with
- 16 RE/MAX. Well, actually, I was the broker for Dimucci and
- 17 then Harper Village. I did those two projects down in
- 18 Ponce. And then I was with RE/MAX. Then I got sick in '06
- 19 with a lung disease, and so I had to take about six, eight
- 20 months off. And then when I came back, I had depleted a lot
- 21 of my working capital, and they offered me to go to there
- for the same split, which is a very good split, 95/5 split.
- 23 And I knew them, because I had sold them one or two
- 24 properties before. So I did that in order to try to build
- 25 my reserves back up. And it was the worst two and-a-half

- 1 years.
- Now, you know, I got a court thing I'm going to,
- 3 and the 17th I have to go to that and do that one. So it
- 4 was the worst two and-a-half years. It was very comical,
- 5 and I may actually write a book afterwards about what I
- 6 witnessed in the two and-a-half years.
- 7 Q. Well, let's talk about that.
- 8 A. I mean, it was really -- it was definitely
- 9 different. Real estate-wise, it was the most bizarre thing
- 10 I've ever witnessed in my life.
- 11 Q. What was bizarre about it?
- 12 A. Just the way they conducted their business. They
- 13 just, you know -- when I first met them, I did two deals
- 14 with them --
- Q. Let's get -- for the record, who's "them"?
- 16 A. Jim Sotolongo. I guess that's his name.
- 17 Q. That's close.
- 18 A. Yeah. Jimmy Sotolongo. I met Jimmy Sotolongo in
- 19 January of '06. I showed him a house. He said he wanted to
- 20 buy the house. And then I met Ramara Garrett, which he
- 21 introduced me to as his girlfriend and realtor from Orlando.
- 22 So they bought that house. They wrote the addendum that I
- 23 was kind of crazy -- I wasn't too crazy about the way they
- 24 wrote the addendum. And I was representing the seller, of
- 25 course. I'm more of a selling agent, seller's side, you

- 1 know, listing agent. So I had an attorney look it over.
- 2 She said it was fine, so we closed it and everything went
- 3 good. It wasn't something that I normally would see.
- 4 Actually, you would see it, you just wouldn't see it in that
- 5 magnitude, you know. A lot of times if people say they want
- 6 \$10,000 to put a new roof on, they want 10,000 credit for a
- 7 new roof or something, that's normal. But this number was a
- 8 couple hundred thousand. I was like --
- 9 Q. As a credit?
- 10 A. As a credit. They wrote for a couple hundred
- 11 thousand credit. I thought it was too high. So my sellers,
- 12 I said, Go -- they hired an attorney, the girl in Orlando.
- 13 She closed it -- I mean a girl up in Ormond Beach. I can't
- 14 think of her name right now, but she's the one who closed
- 15 it. And she said it was fine. I just said, Well, it's just
- 16 kind of out of kilt, you know, the number. And then I
- 17 thought it was a little high. I've been in the business for
- 18 30 years, so I've seen it where, you know -- like, if you
- 19 want a new roof on your house, you're going to go buy a
- 20 house and it needs a new roof, the seller says, Okay, I'll
- 21 put a roof on, but he may use cheesy material, bad
- 22 contractor, whatever. So I'd say, Hey, you know what, let
- 23 me pick my guy, because I might want to upgrade it to a
- 24 better shingle or whatever. Just give me a credit. That
- 25 has been going on for years. But they took it to another --

- 1 they took it to another degree. That's -- and it was --
- 2 that was my first time I've ever heard of American Safety,
- 3 that's some company he owns. American Signature Homes or
- 4 something like that.
- But, anyway, and then I closed another one. Then
- 6 they bought another one just a couple doors down from that
- 7 one. And then I just didn't even talk to him for a while,
- 8 because that's when I got sick. That was in August of '06.
- 9 So I hadn't talked to them. So I closed them two. So I did
- 10 have a working relationship with both of them. Even the
- 11 second one, I had a different attorney, Powell -- was it
- 12 Powell? Mike Kennedy, up in Ormond. He looked that one
- over and he closed that one. So the first two transactions
- 14 I did with them I'm, like, I'm not too sure about these
- 15 guys. And so I had that done. Both attorneys said, No,
- 16 they're legal. You know, it's just the magnitude of the
- 17 property. You know, it's just the size of the property.
- 18 Everything's relative, you know, to the size, I just wasn't
- 19 used to seeing that.
- 20 But then they knew I was sick and they knew I
- 21 spent nine months trying to recoupe. And they offered me --
- 22 they said, Look, we need somebody that's been around for a
- 23 long time to start a real estate company and we want you to
- 24 come on board and we'll give you the same and we'll pay all
- 25 your expenses. I said, Why not? And that's what I did.

- 1 That's how I got hooked -- that's how I got with them. And
- 2 I would have been better off just going back to RE/MAX and
- 3 skip that part, that chapter.
- But it started right from the getgo. Then we got
- 5 right in there and we started doing -- they were doing all
- 6 these kind of crazy things and stuff, and I just was shaking
- 7 my head. See, as an independent contractor, if you don't
- 8 understand -- you probably don't understand how real estate
- 9 works. We're independent contractors. We work for
- 10 ourselves, technically. We just have to have our license
- 11 under a broker, that's all. So, technically, she was
- 12 just -- I had my license hung under her and she was giving
- 13 me a free office space in return for having -- I had been
- 14 around for a long time. Everybody kind of knows who I am in
- 15 the south Peninsula, Ponce Inlet, Wilbur area, so she needed
- 16 a name like that to try to help recruit and do things like
- 17 that. But, you know, there's just things I just -- just
- 18 things -- crazy things.
- 19 Q. What's an example of a crazy thing?
- 20 A. Not paying their bills. Having people coming in
- 21 their front door threatening to kill people.
- Q. Who would do that? Their --
- 23 A. Any vendor that ever dealt with them. I don't
- 24 care who it is, from the lawn mowing guy to a pool cleaning
- 25 guy to roofing contractors. I thought that was kind of

- 1 crazy. People coming and repossessing their car, and they'd
- 2 go make a chain all around their car. Because he
- 3 employed -- Jimmy Sotolongo has, like, six Mexicans, five or
- 4 six Mexicans that work for him full time. Those guys. I
- 5 thought that was strange, too, because I'm not a believer in
- 6 that. If you don't have a card, you need to get back out.
- 7 Q. What do they do?
- 8 A. The Mexicans?
- 9 Q. Yeah.
- 10 A. They did everything Jimmy told them to do.
- 11 Working on houses. Anything they told him to do, you
- 12 know -- he told them to do. Anything.
- Q. Were -- were any of these houses rented for short
- 14 terms?
- 15 A. All of them.
- 16 Q. How did that work?
- 17 A. Well, he had -- they owned a short term -- they
- 18 started a short-term company, rental company. And they
- 19 rented them out by the week, the month, any way they could
- 20 rent them.
- Q. Did they have trouble with the cities over that?
- 22 A. Wilbur. They were having problems with Wilbur,
- 23 because Wilbur has a one-year thing, and they were working
- 24 with one of the politicians down there trying to get it
- 25 changed.

- 1 Q. Who was that politician?
- 2 A. Whoever lives down -- who's the one that lives in
- 3 Wilbur? I don't think he's on -- I don't think he's
- 4 anything now. I think he's -- Bruno. Bruno. Wasn't Bruno
- 5 a councilman there for a while?
- 6 Q. Yeah.
- 7 A. Yeah. I think he was back when -- it was in the
- 8 paper a lot where Wilbur was going after those people for
- 9 short-term rentals. I just -- it was hard for me to
- 10 understand, being in this area so long -- I'm a married to a
- 11 native. I've been here since '88 in the area, in real
- 12 estate since '90. I sold in Orlando for a couple of years
- 13 before I came over here and started selling. But I never
- 14 saw two people come in and make such a big splash. And it
- 15 seemed like they knew everybody and did everything so
- 16 quickly. You know what I mean? It's, like, I'm married to
- 17 a girl that graduated, born and raised here, and we didn't
- 18 know anywhere near or was involved in so much. I quess it's
- 19 just different personalities. I don't know. But it was
- 20 definitely different.
- Q. Did you ever -- do you know Josh Wagner?
- 22 A. Um-hum.
- Q. How do you know him?
- A. Well, because he's in there every day. That's how
- I know him. I'm not a Josh Wagner fan, either. I became

- 1 not a Josh Wagner fan because I lost respect for him because
- 2 he was in there all the time.
- 3 Q. And "there" would be Waverly Properties or Waverly
- 4 Media?
- 5 A. Well, who they -- they were in there talking to
- 6 Jim -- he was in there with Jimmy and Ramara all the time.
- 7 I mean, they would go in the conference room next door and
- 8 talk for hours. Talk -- absolutely talk for hours.
- 9 Q. What were they talking about?
- 10 A. I wish I knew. That's -- that's been a question
- 11 asked to me by -- you're about the third or fourth person
- 12 that's asked me that question. I can't -- I couldn't -- in
- 13 between my office and that conference room was a little --
- 14 the copying room and the shredder room. That's where that
- 15 little room was. But, you know, I would say Josh was in
- 16 there on a weekly basis -- now, I was in the office five,
- 17 six days a week off and on, you know, because I'm showing
- 18 property and selling property. You know, I was dealing with
- 19 my thing. But I would say he was in there at least four or
- 20 five days a week that I physically saw him. My wife and I,
- 21 we've been out, we've seen him out with them.
- Q. What was it about that that caused you to, what,
- lose respect, I think you said?
- A. I lost respect because I knew what Jimmy and
- 25 Ramara were. I knew where they were going and how they were

- 1 acting. I just -- you know, within -- within six, eight
- 2 months of watching them conduct their business with real
- 3 estate and some other things, you know, some other
- 4 businesses that they supposedly owned, I just thought it was
- 5 odd that somebody political -- because I think he was just
- 6 getting into the office at the time. I'm not even sure he
- 7 was there. That would have been in '08.
- 8 Q. Yeah, I think he was in -- running for office
- 9 then.
- 10 A. Yeah, I think -- because I think they really
- 11 helped him, yeah. Because he was -- I was friends with the
- 12 old mayor of Ponce Inlet, the -- what's her name? She lives
- 13 near Old Carriage. The lady --
- 14 Q. I know who you meaning.
- 15 A. I can't get the name out. I've always known her
- 16 because I was in Ponce Inlet, you know. And she kept asking
- me, she says, What's Josh doing in there? Because she was
- 18 running against Josh, I guess, and she was always trying to
- 19 find out what -- what that was all about. And I said, I
- 20 wish I could find out. I have no idea. But, you know, I
- 21 know that he was probably helping them with their -- what
- 22 they were buying and selling. I mean, they did everything.
- 23 I mean, they had concerts on, you know -- they were running
- 24 concerts. They were concert promoters. They had ice cream
- 25 stores they were supposed to have owned and tire stores. I

- 1 mean, they were -- you would think that they were really
- 2 high-end. I mean, they had it all. Now it sounds like they
- 3 didn't really have anything.
- 4 A. I don't understand, because he always seems like
- 5 he was able to make payroll and stuff, you know. That's the
- 6 problem I didn't understand. Because I don't know where --
- 7 I mean, he was making a lot of money on those rentals. I
- 8 mean, he was renting some of his rental houses -- some of
- 9 those houses were oceanfront houses. They were renting for,
- 10 you know, 3, 4, \$5,000 a month for, you know, an oceanfront
- 11 estate. And you -- I mean, it's record. You can tell they
- 12 never made a payment on any of that stuff. I mean, all you
- 13 can do is go to clerk.org and you can see all the -- watch
- 14 from the last time the payments -- most of those properties
- 15 never even had a payment on them, you know. Because the
- 16 foreclosures were so business, you know, they were able to
- 17 hang on to them for four or five years. Well, four or five
- 18 years and you're making 50, 60,000 off of a house, that's a
- 19 pretty good business, especially if the house isn't in your
- 20 name, you know. I mean, I know all that dried up.
- I mean, even the -- like, the sign company, that
- 22 made good money. I don't know what they've done to that,
- 23 but that was a money maker. I knew it -- I -- I rented
- 24 from the sign company before they bought it. I won't rent
- 25 from them now. You know those bench signs?

- 1 Q. Yeah.
- 2 A. But I knew that -- as a matter of fact, I was the
- 3 one that encouraged them to buy it because I knew it was for
- 4 sale. I told them they should consider buying it. I'm the
- 5 one that encouraged them to buy it. There's a -- it was
- 6 kind of falling away, it wasn't being run properly or
- 7 anything. And they hired Jim Brown to fix it, you know, get
- 8 it up and running.
- 9 Q. Were you acquainted with Jim Brown?
- 10 A. Yeah, I've known Jim Brown for -- he sold for --
- 11 he sold real estate magazines probably for about two or
- 12 three years before that. Is was an upscale magazine. It
- 13 was like Real Estate Elite, or something like that. It was
- 14 for high-end properties. He sold -- and that publication
- 15 stopped, and then he went to work for Jennifer Sotolongo
- 16 doing the benches.
- Q. What was his job at the media, Waverly Media?
- 18 A. He went out and sold benches, the benches.
- 19 Q. Are you familiar with their political involvement
- with the bench signs?
- 21 A. I knew that there was -- all's I know is they were
- 22 trading out and getting -- doing stuff, but I don't know. I
- 23 wasn't privy to any of that stuff. But I knew there were a
- lot of people that had benches. I knew Cusack used Jimmy's
- old car lot for her political office, because I'm actually

- 1 friends with -- well, I've sold a couple other properties
- 2 now, the Hulletts. And I told the Hullett -- I told
- 3 Mr. Hullett that they were using -- because I think he had
- 4 it in foreclosure at the time, and Cusack was using it for
- 5 political office at the time.
- I had something that -- if I wouldn't have moved,
- 7 I'd still have it. But I had something. When they were
- 8 doing the pier deal, I had the actual -- I don't know what
- 9 you would call it, the document that's proposed -- the
- 10 proposal that they gave to the county -- or to the city, it
- 11 was about that thick, I had the actual one. Because she had
- 12 it there and she had made a bunch of copies, and I took one
- 13 to read. It was telling about how each one of them had a
- 14 certain amount of experience and all this stuff and why they
- 15 should do it. I was -- because my wife and I would just
- 16 laugh at it, because she said she had all this experience on
- 17 this and this, and I'm, like, wow, this is crazy. Because
- 18 she was a housewife. Her mother was a realtor. And when
- 19 she started -- stopped having kids, she started helping her
- 20 mom in real estate. And then one day Jimmy walks in and she
- 21 fell head over heels over this guy and left her husband.
- 22 And then all of a sudden she had all this experience running
- 23 all these corporations and businesses. And I'm, like,
- 24 that's not true at all. That's not true at all. But I had
- 25 it. And I don't know what happened. When we moved, it got

- 1 put somewhere. And the FBI asked me for it for a couple
- 2 times and I can't find it. But it was a book about this big
- 3 (indicating). And it was a proposal, the actual proposal.
- 4 And it listed all the people that were involved. And I
- 5 think, at the time, you know, it was Josh and Marilyn, the
- 6 people with the pier. And I think at the time Hall was
- 7 involved with it at the time, Hall Construction, because
- 8 that's Josh's father-in-law, was still involved. And I know
- 9 he pulled out.
- 10 Q. The people with the pier, was that Hooper? They
- 11 got the Sunglow Pier?
- 12 A. Yeah. I don't think they own it. Well, they own
- 13 the restaurant. They don't own the pier itself, I don't
- 14 think. Some other guy owns the pier, because they had
- 15 a -- they had -- the Hoopers lent money a lot to the --
- 16 Ramara and Jimmy. You know, private money type of stuff.
- 17 That came up when they went to go have a concert there one
- 18 time. And the City says, well, the Hoopers can't sign
- 19 because they're just a lessee. They couldn't sign for
- 20 the -- you know, to have this concert there. And I don't
- 21 even think Jimmy and Ramara knew the Hoopers didn't own the
- 22 actual pier.
- Q. And that's Sunglow now?
- A. Yeah. They only own the restaurant part of it.
- 25 Yeah, the Hoopers have been involved with them for a long

- 1 time. I think they lent them money on that South Daytona
- 2 project. Well, I know they did.
- 3 Q. What project is that?
- 4 A. The condos there on South Daytona.
- 5 Q. On the river?
- 6 A. Yeah.
- 7 Q. Did you ever hear Jimmy talk about Jim Dinneen,
- 8 the county manager?
- 9 A. No. The people that I heard Jimmy talk the most
- 10 about was Cusack -- well, I mean, Jimmy and -- as far as I'm
- 11 concerned, Jimmy and Wagner was best friends. I mean, they
- 12 were together -- I mean, like I say, my wife and I, we've
- 13 seen them out in restaurants together. I mean, they had
- 14 outside -- it wasn't only just, you know, business-wise. I
- mean, they were really good friends. My wife actually
- 16 brought this to the attention. Like, maybe a year ago when
- 17 they were interviewing Josh about what Jimmy and them --
- 18 when the first story came out about the mortgage fraud and
- 19 Josh says, Well, you know, I didn't really know him, I just
- 20 met him in the last couple of months or something, my wife's
- 21 like, You've got to read this, P.J. Because, I mean, he
- 22 goes clear back as far as I do. I mean, he knew him. He
- 23 was involved with him. It was just funny that he just said,
- 24 Well, I just -- I did business with her. I've just met her
- 25 boyfriend. And I'm, like, Oh, my God. That's hard to

- 1 believe. Anybody that's ever in Ponce Inlet or goes to Down
- 2 The Hatch, Deck Down Under, any of those restaurants, you
- 3 would see them out together all the time. I mean, that was
- 4 -- that was an ongoing -- Josh lives right around -- I mean,
- 5 they were there all the time.
- 6 He had a PR guy. Have you talked to that -- that
- 7 Tony? I don't know what his PR quy was. He did a lot of PR
- 8 work for Jimmy and Ramara. His first name is Tony. Kind of
- 9 a heavyset guy. He -- he was the one that seemed like
- 10 handled a lot of the political stuff. His name was Tony.
- 11 Kind of a heavyset guy. I would think Jim Brown would know,
- 12 because I've seen Jim Brown and Tony and Jimmy and Ramara
- 13 all sit down together. That Tony guy. Whoever that Tony
- 14 guy is, he seemed like -- because I know he was really
- involved with the South Daytona thing, trying to get that
- 16 all cleaned up. Or get it -- when they were buying it.
- 17 That was Tony -- oh, God, I wish I knew his name. I know
- 18 his first name is definitely Tony. Kind of a heavyset,
- 19 older guy. Apparently he's the kind of guy that can -- you
- 20 know, maybe a freelance writer or something. He gets
- 21 articles in and helps -- he knows enough people that he
- 22 makes things happen.
- Q. Funny, he doesn't know me.
- A. Yeah. He probably does. You know, it's -- I wish
- I knew his name, because I think I have heard of him before.

- 1 I was a broker for Dimucci, and we had a lot of PR guys come
- 2 in there, you know, for our promotions and what we were
- 3 doing and all. And I think he was there, too. That's where
- 4 I think I had met him before. They introduced me to him a
- 5 couple of times. But he was in the office a lot. I think
- 6 he had a lot to do with trying to get things -- I know they
- 7 hired him right around the time they were trying to do the
- 8 pier is when I started seeing him. When they were trying to
- 9 do the pier deal. That's -- the pier deal and the condos on
- 10 the river are all about the same time.
- 11 You have to understand, they were trying to do a
- 12 pier deal that was a couple million dollar deal or whatever.
- 13 They were trying to do a concert at the time. And I'm
- 14 sitting an office where the front door is here (indicating),
- 15 and four out of five people that walk in that door are
- 16 looking for money. So as an old, conservative country boy
- 17 from Western Maryland, I just couldn't understand how they
- 18 were doing all this when, you know, an air conditioning
- 19 guy's in there trying to look for \$130 check that he hasn't
- 20 been paid in six months, but, yet, they want to do this
- 21 couple million dollar pier deal. Maybe I just don't
- 22 understand business, but it seems to me that you should have
- 23 money to do those kind of businesses. I just can't imagine
- 24 how you can do it on a shoe string. If they do it on a shoe
- 25 string, then God bless them. But I've never been able -- I

- 1 don't know of anybody like that. It seems like you've got
- 2 to be a little stronger than that.
- 3 Q. Ever heard the word "pin hooking"?
- 4 A. No.
- 5 Q. It a little further south from western Maryland,
- 6 that's a phrase that refers to selling property before you
- 7 buy it.
- 8 A. Yeah. We never did that. We never did that. I
- 9 mean, it's --
- 10 Q. I'm just talking about vocabulary.
- 11 A. Oh. We're just good old country farmers is -- I
- 12 was raised in the farming country, farming area.
- 13 Q. I was too, southeast Georgia.
- 14 A. Oh, really?
- 15 Q. Yeah.
- 16 A. What kind of form?
- 17 Q. Tobacco, cotton, corn, livestock.
- 18 A. We were dairy farmers. 400 head a day, twice a
- 19 day. From the time I was five years old I was milking cows.
- 20 Hence the reason I moved to Florida.
- Q. Well, surely you had the machines to do that.
- 22 A. Well, yeah, we did, but nothing like today.
- 23 Because my uncle runs one now that they just -- you don't
- 24 even -- the herds now just come in, they all have ankle
- 25 bracelets on, and, you know, they all file in line, and

- 1 based on their ankle bracelets, they're trained, and they
- 2 all back right in. Guy goes in, cleans them, hooks them
- 3 out, you know, you got counters on there for how much milk
- 4 each one's putting out. They drop off, they go. The next
- 5 herd comes in. You don't even do any of -- I mean, I was
- 6 out there with a three-wheeler bringing them in in the snow,
- 7 you know, with a hose trying to get it all off. You know,
- 8 it was -- it's changed a lot in 35, 40 years.
- 9 Q. Sounds like fun.
- 10 A. Yeah, right. Well, now today it would be fun.
- 11 Back then it wasn't fun.
- 12 Q. Did you ever hear Jimmy talking about politicians
- 13 that owed him favors, that he had done favors for?
- 14 A. No, not in that sense. No.
- 15 Q. In what sense?
- 16 A. Not in the sense that they owed him. I would hear
- 17 more, like, well, you know, we're going to take care of
- 18 this -- if we can do this, maybe we can -- you know, that
- 19 will help us here. You know, P.J., if we can get -- if we
- 20 can get him elected, you know, maybe we can get this, you
- 21 know, approved or something like that. That's why the whole
- 22 Cusack -- that's why he pushed Cusack, because I think
- 23 Cusack was a deciding factor for the pier. I think she was
- 24 a deciding factor for the pier.
- Because, remember, I'm a republican. I mean, I'm

- 1 very open about it. I mean, I'm very proud of it. And he's
- 2 as liberal, I mean -- when the president was running, this
- 3 Obama was running for president, he was standing out --
- 4 Jimmy was, and Ramara, Jimmy and Ramara, were standing out
- 5 in front of our building with an Obama mask on and she had a
- 6 Michelle mask on waving to everybody. I thought that was
- 7 funny. And, you know, here I am selling high-end properties
- 8 in Ponce Inlet, and my people won't even coming into the
- 9 office because they're seeing this. I'm getting phone
- 10 calls, e-mails and everything. So, yeah, we differed so
- 11 bad, and that's why Jimmy and I -- I mean, the last year we
- 12 hardly even spoke. I just tried to stay completely away
- 13 from him. I mean, I just didn't want anything to do with
- 14 him. We differed so much.
- 15 And what surprises me is Jim Brown was -- he's a
- 16 member of the Volusia Republicans. And I just -- I was
- 17 really surprised that he -- he bowed down. I mean, you
- 18 know, you've got to stand on your beliefs. That's really
- 19 all you have, you know what I'm saying? And he bowed to
- 20 Jimmy based on that. It was just really -- I got all these
- jokes from -- on eBay -- e-mailed to me from Jim Brown
- 22 about, you know -- political jokes, you know. And I'm,
- 23 like, then you turn right around and kiss his butt. Stand
- 24 up to him, you know what I mean? It's like -- you know, you
- 25 just -- I mean, he -- well, they made a comment to me one

- 1 time about who I was supposed to vote for. And I said, No,
- 2 I'm not. There's no way. I'm not voting for that. I
- 3 didn't participate in any of that stuff. I didn't
- 4 participate in the --
- I was independent contracting towards the end. I
- 6 worked more out of my truck than I did out of my office. I
- 7 just didn't want to be a part of it. I actually -- it
- 8 effected my business, you know. Because a lot of my
- 9 business is Ponce Inlet people, Wilbur people, and they just
- 10 weren't going to come to that office. You know, they knew
- 11 what was going on. And, you know, it really hurt me. They
- owed me a bunch of money, so I was trying to get my money
- 13 out of them.
- 14 Q. If they knew what was going on, what do you mean
- 15 by "what was going on"?
- 16 A. Well, it was out on the street that they were bad
- 17 people, you know what I'm saying? And they were -- you
- 18 know, and I was trying to get out of there. I mean, every
- 19 time I'd run into one of my friends, they were like -- or
- one of my customers, they'd say, P.J., you've got to get
- 21 away from them. You got to get away from them. I was,
- like, They owe me 35,000, they owe me \$40,000. They always
- 23 owed me money. When I left -- the last time I left they
- owed me 32,000. My dad had just went into a nursing home in
- 25 Maryland. I just came home. And I told them to give the

- 1 check to my wife, that I was up taking care of my dad in
- 2 Maryland. And they wouldn't give her the check. They
- 3 wanted part of the check. They needed some money, I guess.
- 4 They were using my money for three weeks is what they were
- 5 doing. And I came down there. And then he and I -- when he
- 6 took a shot at me -- Jimmy took a swing at me.
- 7 Q. Took a swing at you?
- 8 A. Yeah. When I asked him for -- I asked -- I went
- 9 into Ramara, and I said, Ramara, I need my money, it's been
- 10 three weeks now. And she says, Well, we don't have it. So
- I went up to the account, Michelle, and I said, Michelle, I
- 12 need the money. Well, Jimmy's there. Jimmy says, We'll
- 13 give you money when we want to give you money. I said,
- 14 Look, you have nothing to do with the real estate company.
- 15 You just need to stay away from me. You're not a broker. I
- 16 don't work for you. Just stay away from me. Because I had
- 17 not even talked to him. He says, Well, he says, we want 10
- 18 percent. I said, No, that's not our agreement. I have an
- 19 agreement, I get 95 percent, I want my check. And then it
- 20 just got heated. And then he took a swing at me and he
- 21 grabbed me and I just pushed him back. And then I went down
- 22 to Ramara, I said, Ramara, you got two choices. I said --
- 23 because people witnessed it. I said, I'm calling the cops
- 24 to have him arrested for assault, or you're going to write
- 25 me a check, you're going to walk it down to SunTrust, and

- 1 you're going to cash it and bring it back to me in a hundred
- 2 dollar bills. I said, I'm either going to have him thrown
- 3 in jail -- and that's how I left.
- Q. Did you get the money?
- 5 A. I got the money. She gave it to me in a
- 6 heartbeat. And I looked at her and I said, If I was you --
- 7 I was shaking at this point. Because, really, as a broker,
- 8 you don't want to be in a fight. You don't want to have
- 9 a -- you don't want to get into that kind of stuff, you
- 10 really don't, because it just looks bad and it's not good --
- I mean, I have a broker's license. I've been a broker for
- 12 35 years. I've never even had anybody write a complaint
- 13 against me. So I wasn't going to go get into a fight with a
- 14 hoodlum, you know, that had nothing to do with my money, you
- 15 know. But I got my money. I left a couple of listings.
- 16 She even signed over my listings to me, because she knew
- 17 that I had him, because, I mean, I had three people sit
- 18 there. They were ready for me to call the cops. He would
- 19 have went to jail that day. That was just -- that was just
- 20 wrong, you know. They held my money over what they owed me
- 21 all the time. That's -- I had to fight for my money.
- Q. Had you ever known him to make physical threats to
- 23 anybody else?
- 24 A. Oh, yes. Oh, yes.
- 25 Q. How did that --

- 1 A. He bragged about it. That's one of the things I
- 2 was upset about. Down at River -- well, there's some condos
- 3 in Ponce Inlet. I think it's Ponce Inlet Villas. As you
- 4 enter into Ponce Inlet, left-hand side, those three-story
- 5 gray buildings. Somebody was down there one day, and he
- 6 went down there and he came back and bragged that he hit
- 7 that guy. I'm, like, You can't do that. That was like
- 8 after a year I worked there. I said, You just can't -- you
- 9 can't go and beat somebody up. It was because they weren't
- 10 allowing him to do renovations on a unit because he didn't
- 11 have a permit. He'd just bring his Mexicans in and they'd
- 12 work on it. But, yeah, he -- well, he's actually -- yeah, I
- 13 mean -- I have a weapon's permit. I carry a gun now.
- 14 That's how bad it is. Yes, I do. And I don't even -- I'm
- 15 renting a house right now because I don't want him to know
- 16 where I live. That's how bad it is. Until he is --
- 17 something happens to him, I mean, I think he's bad news.
- 18 Very, very bad news.
- 19 Q. Do you know Jim Dinneen?
- 20 A. I don't know Jim Dinneen.
- Q. County manager?
- 22 A. I know he's a county manager, but I don't know
- 23 him.
- Q. Do you know where he lives in Ponce Inlet?
- 25 A. I know he lives in Ponce. He lives on -- does he

- 1 live on Inlet Harbor or South Turn? Where does he live? I
- 2 think he lives in the south end somewhere. No, I don't know
- 3 him, though, no. Somebody asked me that, if I've ever seen
- 4 him in there, and I said, no. I don't even know who he is.
- 5 I couldn't even tell you what he looked like. The one -- I
- 6 can tell you, though, Josh Wagner was there all the time,
- 7 and they were out. They were really, really tight. And
- 8 until then, I didn't even know who Josh Wagner was. In the
- 9 last year, what I just read in the newspaper, I don't like
- 10 him, because I know by being there, I know what he's telling
- 11 the newspaper, that he wasn't -- didn't know these people
- 12 and all that kind of stuff, I know that's not true. That's
- 13 why I don't like him. And one of my best friends in real
- 14 estate knows him really well. I guess his daughter was
- 15 raised with him. He even agreed. He said, He's changed.
- Q. Did you have any familiarity with Jim Brown's
- 17 political activities supporting democrats with the --
- 18 A. Well, that's not -- that would shock me. That
- 19 would shock me. Because he was as republican as you can
- 20 get. If not, then every time he sat down, like you and I
- 21 candidly, then he was lying to me. Or all the e-mails --
- 22 and I've got e-mails since then from him picking on the
- 23 democrats. So that just shocks me. I think he did it all
- 24 to bow down to Jimmy Sotolongo. I don't know whether he did
- 25 it in fear. I don't know what it was. I mean, I've known

- 1 Jim Brown -- like I said, he sold advertisement. I met him
- 2 selling advertising two or three years before Jimmy even
- 3 showed up into town, so -- but then I have to tell you that,
- 4 you know, you read in the newspaper about these people, like
- 5 Jim Brown, and if you would have told me that he killed
- 6 somebody or was involved in a murder, I was stunned, because
- 7 that's not the story he's ever told us. Like, you know, he
- 8 always said he lived in Australia, ran a business. And
- 9 somehow they asked him to leave the country because he
- 10 wasn't paying his taxes or something right. That's what the
- 11 story he always said. And we're, like, okay, I understand,
- 12 you know. Because he is really kind of a smart guy. He's
- 13 intell -- seems to be very intelligent. Does a lot of
- 14 reading. You know, he's up on a lot of things. And so
- 15 that's always what he's said. It's, like, Where have you
- 16 been? He says, Well, you know, I've lived in Australia for
- 17 20 years. Oh, that's cool, you know. We even talked about
- 18 my daughter went to Australia, like, for -- back in '07,
- 19 '06, when I first met Jim, she went over there for that
- 20 Basner (phonetic) thing where they go over there as students
- 21 and they study for two months, my daughter. So we had a lot
- 22 in common talking about different, you know, parts of
- 23 Australia and all. And I said, Why did you ever leave if it
- 24 was so nice? He says, Oh, I was running a business. They
- 25 didn't like the way I was paying my taxes or something so

- 1 they deported me, is what he told me. And then six months
- 2 ago I read that he -- he was involved in a murder. And
- 3 we're, like, what, what? Because, you know, knowing
- 4 somebody like this, that would be like you finding out
- 5 tomorrow I shot somebody. It's like, That's just weird, you
- 6 know, to me. I guess it's just -- I guess I'm a little bit
- 7 on the naive side, you know what I'm saying? I guess that's
- 8 what it is. I was just stunned by that. I would have never
- 9 thought he -- because he always came across as a pretty nice
- 10 guy. The only thing, like I said, I don't like about him
- 11 was one side of his mouth he talked. That's all he was, he
- 12 was important, you know. He was a very republican based,
- 13 very conservative-based person. But then he did the
- 14 opposite because of what Jimmy said. Everybody in there
- jumped for whatever Jimmy said. I was probably the only one
- 16 that didn't. Well, there's a couple other guys, but they
- 17 all left, realtors that I had recruited that left.
- 18 Q. Did you follow, in the newspaper, Jim Brown's
- 19 pleading guilty to filing false campaign reports?
- A. Um-hum.
- Q. Did you have any observation of that process?
- 22 A. I don't know if that happened or not. I don't
- 23 know. I don't know any of that. They would not share
- 24 any -- that's why they went in behind doors all the time,
- 25 because they know that -- I was totally against all of that

- 1 stuff. They would not -- they just didn't bring it up in
- 2 front of me. They knew how I was. I was very staunch.
- 3 Q. Well, the --
- 4 A. The person that I would think out of all of them
- 5 that would probably know the most out of all that stuff was
- 6 Kim Was. That girl. Kim Was, she still works for them, and
- 7 she's pretty tight with them. And it just shocks me that
- 8 she, you know -- she's a good girl from Ohio. She came
- 9 here. She had no experience and she came to work as our
- 10 secretary. But I think she knows so much, that I would be
- 11 surprised -- they would never, ever have used my name to buy
- 12 a democratic -- I would have just -- I would have went off.
- 13 I would -- they know better.
- 14 Q. They used her name?
- 15 A. I'm sure they probably did. They would never have
- 16 done that -- even Jim Brown would have said, No, you got to
- draw the line, because not P.J. Warner. Because everybody
- 18 knows that I'm just the opposite.
- 19 Q. If I were to tell you that one of the witnesses
- 20 I've talked to says that that process of picking out
- 21 candidates and doing that free bus bench thing where they
- 22 filed the reports and had a strawman claiming he gave them
- 23 money for it, that the witness says that Jim Brown, all by
- 24 himself, was deciding which candidates to give that favor to
- 25 with no direction from Jimmy Sotolongo. Would that strike

- 1 you as plausible?
- 2 A. I would be totally -- that could not be true at
- 3 all. There is no chance in -- there is no way. Jim Brown
- 4 did what Jim Sotolongo said. Jim Brown would not pick any
- of those people ever. That's -- there's no way that could
- 6 be true. That would be -- that would be -- there's no way.
- 7 No. No way. No, no.
- 8 Q. If I told you that I -- and I will tell you, I've
- 9 been talking to several witnesses that names have come up in
- 10 this. Who would you think would have told me that?
- 11 A. Well, the one that's probably most in debt with
- 12 Jimmy Sotolongo is Josh Wagner.
- 13 Q. And why would Jimmy -- assuming Josh told me that,
- 14 which is a good assumption, why do you think Josh would want
- to say that to us that in this testimony?
- 16 A. I have no clue. I have no clue. But Josh Wagner
- 17 and Jimmy Sotolongo are in bed together. I mean, that's the
- 18 bottom line. They've been from day one. You know,
- 19 that's -- I mean, the FBI has questioned me about a lot of
- 20 this stuff. And I said, I wish that there was something in
- 21 writing that I had. Actually, my laptop that I had bought
- 22 was there, crashed, so I've got a hard drive, and I've
- 23 got -- been able to go back to AOL and go back a couple of
- 24 years. I've got some stuff for Ramara, it's from Stephanie,
- 25 but nothing politically-wise. It was only for the real

- 1 estate side. I couldn't find anything on Jimmy. Again, the
- 2 last year I didn't talk to Jimmy. I mean, Hi, get out of my
- 3 face. I mean, it was just like that, you know. I'm
- 4 dwindling my listings down and going to get away from here,
- 5 and I'm trying to get away from you because I can't deal
- 6 with -- you know, you have somebody sitting here trying to
- 7 buy a million dollar house and some guy walks in with a
- 8 baseball bat, swinging a baseball bat, and says he's going
- 9 to clean this place out until he gets his \$136 check for the
- 10 recharge of his air conditioner that he's owed for six
- 11 months. You can't do business that way. That's not the
- 12 atmosphere you can do business.
- Q. Did you have somebody come in with a baseball bat?
- 14 A. Absolutely. Oh, yeah. I've had people with a
- 15 baseball bat. I've had a tow truck back up to the front of
- 16 her green car, that big green car that she drives -- that
- 17 Ramara used to drive. I don't know if -- I think the
- 18 mother's driving it now. The tow truck backed up to
- 19 repossess it and he took the Mexicans -- he came flying in
- 20 with his truck, put the Mexicans all around it, and Jimmy
- 21 was in that tow truck driver's face like that and the guy
- 22 left. I couldn't believe it. I mean, it was bizarre stuff
- 23 like that. Yeah, there's nothing -- I'd see guys standing
- 24 out in the driveway throwing rocks at our building, you
- 25 know, wanting their money. You know, I mean, that was

- 1 nothing. Tow truck guys trying to repossess cars, air
- 2 conditioning guys trying to get paid. It was a daily
- 3 occurrence there. Daily. They would -- towards the end,
- 4 Jimmy and Ramara never even came to the office. You know
- 5 when they went to the office? 9:00, 10 o'clock at night,
- 6 because they didn't want to run into anybody. So that's
- 7 what I'm saying, that last year, year and-a-half, year and
- 8 couple -- I didn't even see them. I didn't want anything to
- 9 do with them. I'm going to write a book, I'm telling you,
- 10 from some of the stuff I saw. It just amazes me.
- 11 Q. Well, you've got some good notes for your book.
- 12 A. I mean, well, the craziest thing is one of the
- 13 things I'm going to be talking about there -- the craziest
- 14 thing, I'm standing in the front lobby -- this is the
- 15 craziest thing I ever saw. But I was standing in the front
- 16 lobby talking to the secretary, which she's been on record,
- 17 and Kim Was was there. He goes in -- the processor comes in
- 18 to serve. He says -- and he walked in that door. He
- 19 normally comes in the front door. There was the three
- 20 doors, one door was always locked, then you had the main
- 21 Waverly door, which brought it in to where my office was,
- 22 and then you had the rental office, which we kind of kept
- 23 separate to keep the renters out of our office. That
- 24 processor went in that door. The processor walked right up
- 25 to Jimmy as he was sitting there and he says, I'm looking

- 1 for Jimmy Sotolongo. And Jimmy, with his cold face, just
- 2 looked him and says, Well, which one? And the guy says,
- 3 Well, is there more than one? He goes, Oh, yeah. He goes,
- 4 Well, I'm looking for James L. or James, whatever,
- 5 Sotolongo. And he goes, Oh, that one's out of the country.
- 6 And turned right around and left. There's only one Jimmy
- 7 Sotolongo that I -- Lord, I hope there's only one Jimmy
- 8 Sotolongo. And we -- and Barb Aiken (phonetic) and I, we
- 9 sat there and we're, like, How can he do that? I mean,
- 10 that's like -- that's lying to a federal -- I mean, that's
- 11 lying to an officer.
- Q. Was this -- was this a deputy?
- 13 A. Yeah. It was a deputy serving -- well, it was a
- 14 -- they're not deputies, are they? Well, it was a county
- 15 guy, yeah. It was a processor, process server, or whatever
- 16 it is. He just flat out lied to him. I'm, like, really,
- 17 can you do -- and he was -- honestly, he's the best liar
- 18 I've ever seen in my life. There's nobody better than Jimmy
- 19 Sotolongo when it comes to it. Because he had us all
- 20 believing -- when I went to work for him, I believed that he
- 21 was a famous promoter. That he promoted fights and all this
- 22 stuff down in South Florida. I believed that he had a lot
- 23 of money. I mean, he's very -- he came across very
- 24 charismatic and I believed -- I believed everything. It
- 25 took about seven or eight months of setting in that office

- 1 and listening to stuff and seeing things happening, you
- 2 know, and going to a copy machine and seeing stuff or
- 3 whatever, knowing that they're all bullshit. It was all
- 4 bullshit. You know, it was just all front.
- 5 Q. Did you ever hear them talk about the Halifax Area
- 6 Advertising Authority, HAAA?
- 7 A. Hum-hum.
- 8 Q. Discuss Joyce Cusack helping them --
- 9 A. Joyce Cusack was helping them with the pier deal,
- 10 as far as I know. That was -- she was -- they rendered her
- 11 opinion and stuff like that. That's about the same time, I
- 12 think, she used their -- their building for --
- 13 Q. Yeah.
- 14 A. -- for her campaign office, that he wasn't making
- 15 mortgage payments on, by the way. Because, you know,
- 16 legally -- you probably know that, because you're an
- 17 attorney. But, legally, if you own a property and you're in
- 18 default, you -- any rents -- especially on commercial
- 19 property. Any rents -- and, actually, even the oceanfront
- 20 houses, if you collect rent, that is absolutely the property
- 21 of the -- of the person who holds the mortgage.
- 22 Q. Yeah.
- A. And that's why I can't understand why nobody's
- 24 ever gone after him for that. And it's even like Hullett.
- 25 I'm like, he wasn't paying you, but he's collecting rent --

- 1 or I guess he was giving her a gift, or whatever, for her
- 2 office. But still, you know, a property like that's worth,
- 3 you know, maybe 15, \$1,800 a month to rent. And it's, like,
- 4 he's giving all this money, acting like he's a bigshot, but
- 5 he's not even making the mortgage payments on it.
- Q. Well, actually, the campaign reports show that
- 7 Ms. Cusack reported that she had been given an in-kind
- 8 political contribution of the use of that office, which she
- 9 valued at \$250 a month. Does that sound right to you as a
- 10 number?
- 11 A. Well, I'll rent it for 250 a month. You want to
- 12 rent me a one-acre parcel on ISB with an office building on
- 13 it? Yeah, I'll take it for 250 now. I'll even sign a 50
- 14 year lease. No problem.
- 15 Q. In other words, you're saying that is
- 16 unreasonably --
- 17 A. 250 a month? It's a one-acre paved, enclosed
- 18 park -- I mean, it's a -- it's a car lot. I don't know if
- 19 you know where it is. It's right next to Spano's, or
- 20 whatever it is.
- Q. Spano's?
- 22 A. Yeah. The only thing that's different is there's
- 23 a little insurance company, I think, in between. Yeah.
- 24 Well, it's a 350, \$400,000 property. So you can't rent --
- 25 no. Yeah. You can't rent for that.

- 1 Q. And that would be your professional opinion as
- 2 a --
- 3 A. I pay \$400 for a -- in my private office that I
- 4 have in RE/MAX, I pay \$400 for a eight-by-six cubical.
- 5 That's what I pay. So that tells you something. The office
- 6 is above Waverly building, when they were trying to rent
- 7 them, before Jimmy just used them all. But we were trying
- 8 to rent them. We were asking 550 for an office that was
- 9 half the size of that, not even including the big lot that
- 10 you could sell cars on. So, no, that would be nowhere near
- 11 the going rate. Look at his tax records and see what he was
- 12 claiming for what it was worth. That's what I'd do. If he
- 13 filed taxes. I don't think he ever filed taxes. He always
- 14 bragged about that.
- Q. Well, in the area of -- what I'm investigating for
- 16 the county council is the question of the use of those bus
- 17 bench ads in the political campaigns without properly
- 18 reporting it and attributing it to someone who really paid
- 19 for it. Do you have anything to offer on that subject?
- 20 A. No. He -- again, they wouldn't share any of that
- 21 with me because they knew that I didn't -- I didn't support
- 22 anybody they supported, let's put it that way. Whoever they
- 23 were is usually on the opposite side of where I would be.
- 24 The only thing I could tell you is I've heard him say
- 25 certain people they would have liked to have been elected to

- 1 help get that pier deal, and that was Cusack and Josh, and
- 2 they were trying to make sure that that happened for those
- 3 guys. That was kind of like their -- that's the two main
- 4 people that I heard about. Josh was a fixture. I mean, he
- 5 was -- he was there. I mean, it's -- it's not -- you know,
- 6 he'd stop in on his bike, but he always went into the room
- 7 to talk. He would never do it out there.
- 8 Q. Okay. Well --
- 9 A. I can't imagine, though, Jim Brown ever -- no,
- 10 that's just -- Jim Brown would never support anybody that's
- 11 a democrat. I would be surprised. If not, he just was
- 12 wrong with me. They would have never put me on any of those
- 13 things because they knew how I felt. I would have went off.
- 14 Because I seen him using other people's names, like the
- 15 people that worked there and all, yeah, I could -- because a
- 16 lot of those people feared for their jobs. So, you know --
- 17 but, see, I was an independent contractor. I didn't
- 18 really -- I mean, I knew I could walk out of there. I was
- 19 probably going to lose 30, 40,000 when I walked out of
- 20 there, but I was always in that position that I could have
- 21 walked out. And I finally did. Kim Was. The guy by the
- 22 name of Tony, if you could get ahold of him, that would be
- 23 the one.
- Q. Tony. I'll have to write that one down.
- 25 A. Jim Brown will tell you who it was, guarantee you.

- 1 Because him and Jim, they were tight. They were tight, too.
- 2 Q. Yeah, well, first I've got to get the judge to
- 3 order Jim Brown to obey my subpoena.
- 4 A. Because Jim Brown -- Jim Brown would be the one.
- 5 Like I say, Jim and Jimmy were -- you know, they would all
- 6 go back in that little room and just do their little
- 7 pow-wow. Because they knew -- I mean, I was very objective.
- 8 When they said something to me, like, You know, you got to
- 9 help push Josh. You know, you've got to help do this, you
- 10 got to do that. I'm like, No, I don't like Josh. You know,
- 11 you're not going to change my beliefs. I mean, I'm a
- 12 right-winger. I am I don't work for you, you can't tell me
- 13 what to do. I mean, that's where I'm going to stay. And
- 14 that's not who I go with. So I don't work for you. You
- 15 can't tell me what to do. You know, I'm an independent
- 16 contractor. I've been for 30 years. And I've got my own
- 17 beliefs, and that's it. So that's why I never -- he --
- 18 that's why I don't think they would share much with me,
- 19 because they knew how I was. I would tell them about it.
- 20 But, you now, they -- whatever -- Jimmy ran that show.
- 21 Ramara -- if he told Ramara to jump, it was how high.
- 22 That's all she would ask. Jimmy was definitely the show.
- 23 And I don't think anybody that worked at Waverly Media would
- 24 do anything unless Jim Sotolongo told them to. And he would
- 25 only do it if he was getting a favor. He wouldn't do

- 1 anything for anybody unless he was getting a favor. I mean,
- 2 that's common sense. And anybody that knows Jimmy Sotolongo
- 3 will tell you that.
- 4 Q. You were interviewed by the FBI?
- 5 A. Um-hum. Deposition. Trial is on the 17th.
- Q. You're scheduled to testify in federal court?
- 7 A. Yeah.
- 8 Q. Do you think that's going to happen?
- 9 A. Um-hum.
- 10 Q. It's been postponed about 14 times.
- 11 A. It won't be this time. They're trying to change
- 12 the judge, because the judge -- I think it's going to
- 13 happen. Yeah. I've been with the FBI. Yeah, like, 76
- 14 deals, and four or five of them were my listings. But
- only -- out of the 14 that they're actually prosecuting on,
- 16 two of them were listings that -- and both of them were the
- ones that I had attorneys for. So I -- mysteriously all of
- 18 her files were missing for her real estate. But I always
- 19 carry files. As a broker, as an agent, I have every file
- 20 that I've ever done, clear back to 1981. So I just keep
- 21 them all. It's just what I do. I don't know. I guess I'm
- 22 a hoarder when it comes to those files. But they do come in
- 23 handy. But I've shown them all of those files, so I've been
- 24 really helpful, I think, in that aspect.
- 25 Yeah, I think it's going to happen. The reason

- 1 why I think it's going to happen is because Jimmy and Ramara
- 2 are the type of people that don't think they've done
- 3 anything wrong. They're like -- they feel like they're
- 4 above everything, they're above everybody, and they are
- 5 convinced that they didn't do anything wrong. I don't know
- 6 how you can. If you have an account and you've got a bogus
- 7 LLC and you're dumping millions of dollars in that LLC and
- 8 the only people's names are yours and Jimmy's, I don't see
- 9 how you're not involved, how you can't be involved. You
- 10 know, it seems like, to me, it's an open and shut case.
- 11 They should have taken their pleas and go. To me, I don't
- 12 understand -- but they're -- they -- they really believe
- 13 that they're being targeted. They think they're being
- 14 targeted in this. They just believe that they've done
- 15 nothing wrong. And I'm telling you, they're good. When it
- 16 comes to telling stories, they could convince you. I even
- 17 told the FBI guy the other day -- well, Saturday I was
- 18 talking to him. And he -- I told him, I said, I wouldn't be
- 19 surprised if they don't walk out of there and you guys have
- 20 to write an apology letter to them. That's how good they
- 21 are. And they're good, they're sneaky, they know how to
- 22 cover their butts, you know. But, yeah, it's -- I've been
- 23 talking to the FBI once a month.
- Q. Have you heard them -- do you think -- are you
- 25 saying they think they've been targeted in this bus bench

- 1 political thing?
- 2 A. They've not done anything wrong, no. That's the
- 3 way they always come across to anything. Well, I didn't do
- 4 anything wrong. They're going to put the blame somewhere
- 5 else.
- Q. Well, you know, Jim Brown pled guilty to that
- 7 campaign --
- 8 A. Um-hum.
- 9 Q. -- fraud, and got probation. Do you think he
- 10 was -- he was taking the fall for Jimmy?
- 11 A. No. I don't think, I know. I would be
- 12 surprised -- no. Because Jimmy fired him that week, the
- 13 same week that he did it. No, I don't think so. Unless I'm
- 14 really misunderstanding, I don't -- unless Jim really got in
- 15 bed with him, I never got that impression. I mean, I think
- 16 Jim Brown did what Jimmy told him to do because he liked his
- 17 paycheck, for one. But I don't think Jimmy -- I don't think
- 18 Jim Brown and Jim Sotolongo had the same political beliefs
- 19 at all. Not even -- I don't even think they were on the
- 20 same page. If not -- all those -- I mean, I would get
- 21 e-mails from Jim Brown once or twice a day that would
- 22 totally contradict what Jim Sotolongo would like. So, no, I
- 23 can't understand why Jim Brown would take the fall. I don't
- 24 think so. I think he probably took the short road, you
- 25 know, because he's got a wife, he's got a kid. I think he

- 1 probably made it less painful for him, is what I think he
- 2 would have done. I don't think he would --
- 3 Q. And he got a pretty good deal.
- 4 A. That's what I'm trying to say.
- 5 Q. Probation --
- A. And I think it was probably trying to get him to
- 7 talk more. And I don't know why he wouldn't, because --
- 8 but, I mean, he would be the one that would know it. But
- 9 Jim Brown wasn't the one going out and finding the
- 10 politicians to support -- it was Jimmy and Ramara and that
- 11 Tony guy. There's a Tony guy that was involved.
- 12 Q. So far all I've got in my notes is Tony guy. I'm
- 13 going to track him down.
- 14 A. Yeah. Jim Brown will probably -- Jim Brown will
- 15 tell you who it was.
- 16 Q. I've got to get him across the table from me
- 17 first.
- Were you interviewed by anybody from the State
- 19 Attorney's office regarding the political --
- 20 A. I'm supposed to be.
- Q. Are you scheduled for one?
- A. Tomorrow morning, 10 o'clock.
- Q. When was the first time you heard from the State
- 24 Attorney?
- 25 A. Last Thursday. Thursday or Friday they showed up

- 1 at my house.
- 2 Q. With a subpoena?
- 3 A. With a subpoena.
- 4 Q. An investigative subpoena?
- 5 A. Um-hum. Last Thursday, I think it was. And like
- 6 I told him, I said, I really don't -- because my beliefs
- 7 were so bad, they really didn't share anything when it came
- 8 to that. I mean, real estate, I mean, I figured out what
- 9 they were doing, how they were doing it and everything. And
- 10 I've witnessed the shredding of the stuff and I saw all that
- 11 stuff. So that real estate part of it I know pretty well.
- 12 But the political part is only what I would hear, bits and
- 13 pieces here and there, and they wouldn't share it with me.
- 14 I would just laugh at them.
- 15 Q. Okay.
- 16 A. They are interesting people.
- 17 Q. This is your week to be testifying.
- 18 A. Yeah. But this is a lot easier than the FBI. The
- 19 FBI -- the first time I went to the FBI over there in
- 20 Orlando, I think I went down there -- I've talked to them a
- lot here, you know, but then I had to go over and do my
- 22 deposition with all the attorneys and all. And I walked
- 23 into this room about this size, and they had a long table,
- 24 and they have, like, 70, 80 files, and they're all, like,
- 25 this tall. And we sat there for eight hours, went through

- 1 every file to see what I knew about each one of those files.
- 2 Very scary. Very scary, considering that I've been on the
- 3 ethics committee, sat on the ethics committee off and on,
- 4 grievance committees, been a real estate broker since the
- 5 early '80s. I've never even had a complaint filed against
- 6 me. And I'm sitting there looking at all this, I'm like,
- 7 Oh, man, I'm not in Kansas any more. You know, this is
- 8 weird. This is scary. So, yeah. I never even knew that
- 9 they were so branched out, you know. I'm, like, really?
- 10 You know, they're talking about millions of dollars. You
- 11 know, I only knew these couple little deals, you know. And
- 12 I'm trying to think, how did they -- there's got to be some
- 13 money somewhere. There's no way they could have spent that
- money.
- 15 Q. I can't believe the FBI hadn't found it.
- 16 A. Well, I think they have a good -- I think
- 17 everybody knows about where it's at, but they're not --
- 18 Q. Where do you think it is?
- 19 A. It's in the Bahamas. I'm sure it is. Yeah.
- 20 Because, my understanding is, they have a -- they've got to
- 21 own a house or they're renting a house down there, or their
- 22 friend's got a house down there. Somebody down there's got
- 23 a house. You know, they're friends with another guy here in
- 24 town, too, that people know. But -- and has a boat and he
- 25 has a place down there all the time, too, you know.

- 1 Q. What's his name?
- 2 A. He's an attorney here in town.
- 3 Q. What is his name?
- 4 A. Doran.
- 5 Q. Ted Doran?
- A. Yeah. They're friends with him pretty well, too.
- 7 Because that's what everybody keeps guessing. And I said, I
- 8 don't know. I've seen Ted in the office a couple times, but
- 9 I don't know if they're that close. But apparently Ted
- 10 Doran has a house down there, too, right next to theirs, or
- 11 close to theirs. And I'm, like -- but I think you can get
- 12 extracted from the Bahamas, can't you?
- 13 Q. Yeah.
- 14 A. That's why that wouldn't make sense.
- 15 Q. Bahamas are no Brazil.
- 16 A. Yeah. Well, I mean, how about the eastern
- 17 Bahamas, like the Abaco Islands? I'm not sure about the
- 18 Abacos, though.
- 19 Q. I think that's all --
- 20 A. Because the Abacos -- the Abaco Islands are still
- 21 British ruled. So that's why I was wondering if they would
- 22 be from that area, for hiding -- for going there. Somebody
- 23 told me -- the investigator told me that Jimmy's old cell
- 24 mate, or somebody that he met in prison, lives in the
- 25 Bahamas, too, in that same general vicinity. So something's

- 1 going on there.
- Q. What did Jimmy do time for?
- 3 A. I don't know what he did time for. I just know
- 4 that the FBI told me that he had five -- five counts, and
- 5 he -- it's -- drug smuggling was one. That's the one Jimmy
- 6 told us about, about a year after working there. He bragged
- 7 about that one. But then I -- then they told me that one of
- 8 the things that he pleaded out was embezzle money from a
- 9 lending institute, which he is being charged for right now
- 10 from someplace down in South Florida. Then he had
- 11 another -- he had a pot growing facility going on in Tampa.
- 12 And then the other one was embezzling money from another
- institute. So he's got a pattern of embezzled money. I
- 14 think that's what the judge -- why he said, no, no, no, not
- 15 with your history. And he won't be able to go on the stand.
- 16 That's what they're saying. They said, Well, he'll never be
- 17 able to take the stand because he's already got convicted of
- 18 those same charges, basically. That would make him look
- 19 really bad in front of a jury.
- 20 Q. Yeah.
- 21 A. You know?
- 22 Q. Yeah.
- 23 A. That's what the FBI is betting, that he can't even
- 24 take the stand because that could come up then.
- 25 Q. Oh, yeah. It could -- it would.

- 1 A. Well, he's already been convicted of it, you know.
- 2 And I think the actually time he did was on the drug
- 3 smuggling thing. But Jimmy told us he was -- got caught
- 4 smuggling drugs with his brother.
- 5 Q. Tony's last name hasn't come back to you?
- 6 A. No. I wish it would. I can picture the guy. I
- 7 can definitely picture the guy. He had -- he came -- he
- 8 showed up about the time they were doing the condos on the
- 9 river is when he showed up. And, you know, I don't know if
- 10 any of those articles mentioned a Tony or not. He was,
- 11 like, one of those guys that knew all of the right people,
- 12 politically-wise, and that you could hire to kind of
- 13 schmooze over a couple deals, couple things, you know what I
- 14 mean? Get some favors done. That's when he showed up, is
- 15 about that same time. That and the pier, this Tony guy.
- 16 Kind of a stocky, older guy. Maybe early '60s.
- 17 Q. That's not old.
- 18 A. Young guy. And he's -- I mean, that would be one
- 19 I'd be really after. But the only one that I know that know
- 20 that personally -- unless Jimmy Sotolongo told you it was,
- 21 would be Jim Brown. And I know Jim Brown, because I've seen
- those all go into Jim Brown's office and sit for hours. So
- 23 that's the guy. He had something to do with -- he was
- 24 really heavy trying to smooth that South Daytona deal over.
- 25 He was heavy in that. He knew all of the players he said.
