Summary/Highlights:

The National Association of County Engineers and the American Public Works Association seek a special event permit. - There shall be no sale or distribution of products or other material without the prior approval of Beach Services.

- 4. Other items such as trash cans, barricades etc.
- Groups shall leave areas in clean and orderly condition, satisfactory to Beach Safety, including, but not limited to, trash removal and returning the beach to grade.
- The applicant, in exercising the privileges granted by this permit, shall comply with ordinance Chapter 20, Beach Code, Volusia County Code of Ordinances.
- This permit is a revocable permit and may be revoked at the discretion of the County Council, Volusia County or Beach Safety upon 24 hours notice or without notice, if the safety and health of the public is threatened, notwithstanding any other terms or conditions of the permit to the contrary.
- The permittee hereby agrees to save and hold harmless the County of Volusia, its agents and employees, from any and all claims, damages, suits at law or equity of whatever kind of nature for damages to or loss of property or injury or death to persons, resulting directly or indirectly from, or attributable to, the applicant or its employees in connection with the special event authorized by this permit.


INSURANCE

ENVIRONMENTAL CONDITIONS

- 1) Follow the environmental conditions described in the special event permit application.
- 2) This event may also require a Florida Department of Environmental Protection (FDEP) Permit (FDEP; 904-655-1765 or trey.hatch@dep.state.fl.us) for allowance of temporary equipment on the beach after sunset. You must adhere to all conditions imposed by the FDEP permit as well as those additional requirements set forth below. A copy of the FDEP permit must be provided to Volusia County Beach Services prior to the event.
- 3) Volusia County's Habitat Conservation Plan (HCP) requires that all equipment is set-up outside (seaward) of the marked Conservation Zone (CZ), and activities stay off the dune and dune vegetation. Within the Traffic Free Zone (International Speedway Blvd. to Seabreeze Blvd.), the CZ is unmarked. To comply with the HCP, equipment and structures must be set-back at least 15 feet from the seawall or toe of dune. Any damage to the dune shall be restored to its pre-event condition.
- 4) Within the Traffic Free Zone, vehicles will only be allowed for set-up and clean-up of the event and must obey all standard driving rules, including access times (sunrise-sunset, tide permitting). Therefore any equipment to be set-up prior to sunrise or removed after sunset in the Traffic Free Zone must be hand-carried. No other driving or parking of vehicles on the beach in this zone will be permitted. Coordinate with the Beach Safety Headquarters, (386) 239-6414, for access into the Traffic Free Zone.
- 5) Outside the traffic Free Zone all standard public parking and driving rules apply. Vehicular Access may be delayed or prohibited when environmental conditions, such as high tides, warrant.
- 6) All equipment associated with the event and all trash generated by the event must be removed from the site upon conclusion of event activities.
- 7) **Please recycle**. Host a "Green Event" and encourage all participants and spectators to use the yellow recycling bins next to trash cans posted along the beach and promote other ecofriendly activities.

Sec. 20-127. Unattended items.

Unattended portable recreational equipment, including but not limited to, tents, canopies, cabanas, shading devices, chairs, tables, grills, and volleyball nets, on the beach from 9:00 p.m. to 6:00 a.m. is declared to be a public nuisance and shall be removed and disposed of by Volusia County or its designee, except such portable recreational equipment otherwise permitted by federal, state or local law.

ARTICLE V. TEMPORARY USE FOR SPECIAL EVENTS

Sec. 20-141. Penalty.

Violations of this article are punishable as provided in section 1-7.

Sec. 20-142. Policy; objective.

This article is intended to ensure broad beach usage by allowing temporary uses of the beach for purposes which otherwise would be prohibited. These special uses would be allowed by a permit that waives certain restrictions under specific conditions which still protect the public health, safety and welfare. The permitting process is intended to provide a convenient procedure to be followed by beach users and ensure that beachfront cities have notice.

Sec. 20-143. Permit required.

No person shall organize, promote or conduct a special event except as provided in a special event permit issued pursuant to this article. (Ord. No. 87-36, § 5.01, 11-16-87)

Sec. 20-144. Reserved.

Editor's note—Section I of Ord. No. 97-2, adopted Feb. 6, 1997, deleted § 20-144 in its entirety. Formerly, § 20-144 pertained to permits for small events and derived from § 5.02 of Ord. No. 87-36, adopted Nov. 16, 1987; § 3 of Ord. No. 89-34, adopted Aug. 25, 1989; and § I of Ord. No. 93-5, adopted Feb. 18, 1993.

Sec. 20-145. Permits for special events.

A special event may be permitted by the beach director if the special event facilitates the recreational use of the beach in accordance with the philosophy set forth in section 20-4. Such a permit shall according to its terms constitute a temporary waiver of one or more provisions of this chapter. An application for such a special event shall be filed with the beach director containing pertinent information such as time, date, place and nature of the event, crowd size, commercial sponsorships and any other information reasonably required by the beach director. No permit shall be issued by the beach director for waiver of any provision of this chapter and unless he shall be reasonably satisfied that the public health, safety or welfare will not be endangered thereby; the permit is consistent with and will facilitate the customary recreational uses of the beach: the use of the permit will not constitute an undue intrusion upon established residential neighborhoods adjacent to the beach; and the permit conforms to any plan for zones of use then in effect. After the beach director is satisfied that the application is complete, a copy of the application will be delivered to any municipality that is affected by the proposed special event for its review and comment, including whether or not it will provide any services that may be needed by the special event. Such comments as the municipality shall desire to make shall be provided within two weeks. Upon conclusion of the period for comment, the beach director shall grant or deny the permit. If the permit is granted the beach director shall issue the permit with all conditions included therein. Conditions shall include payment of on-beach costs, and off-beach costs directly attributable to such event, insurance and any other reasonable conditions. The beach director will then transmit the permit to the municipality and the applicant. No permit shall be issued waiving the provisions of this article concerning alcoholic beverages or temporary closure of a portion of the beach to vehicular traffic unless the beach director obtains approval from the county council. The determination of the beach director will be final unless the applicant or municipality appeals the same to the county coun-

cil, in which event the county council shall review the decision of the beach director and make a final determination thereof.

Sec. 20-146. Effect of permit; violation of permit conditions.

A special event permit will preempt or waive otherwise conflicting provisions of this chapter as provided in the permit. Violation of the terms of a permit will be cause for immediate revocation of the permit by the beach director and a violation of this chapter, and shall be punished as provided for in section 20-141.

Sec. 20-147. Commercial events.

Provided that the event is not to be held directly opposite a residential neighborhood, commercial events shall not be denied a permit under this article solely because the event involves the promotion or advertisement of commercial or business interests. Reasonable franchise fees may be imposed by the county council as a condition of the permit.

ARTICLE VI. TRAFFIC AND VEHICLES*

DIVISION 1. GENERALLY

Sec. 20-171. Penalty.

Violations of this article are punishable as provided in section 1-7. (Ord. No. 87-36, § 6.06, 11-16-87)

Sec. 20-172. Objective; policy; authority of enforcement officials.

(a) The objective of this article is to provide motor vehicular access to the beach during daylight hours subject to conditions that will promote separation of motor vehicles and people on the beach, conserve as much as possible of the beach for use by pedestrians, promote an even, uncongested flow of traffic along the beach and onto and off approaches, discourage unnecessary beach traffic, and give notice of hazards that remain. No provision of this division shall be deemed to create a duty of care not otherwise existing as a matter of law.

- (b) The beach director and all law enforcement officers with authority for traffic enforcement on the beach shall provide by the placement of signage and by traffic direction and enforcement that traffic is restricted to a single lane of northbound traffic and a single lane of southbound traffic. A single driving lane will be approximately ten feet wide. The western edge of the southbound lane will be set at the mean daily high tide line and extend eastward ten feet. The northbound lane will extend an additional ten feet east. The parking area will begin at the mean daily high tide line and continue 30 feet west. At no time will the parking area encroach into the conservation zone. except in those areas specifically delineated in subsection 20-272(a). The beach director may authorize one driving lane in those areas deemed appropriate by the director. The beach director and all law enforcement officers shall direct that drivers park their motor vehicles in an orderly fashion to conserve parking spaces. In the discretion of the beach director or his designee, if there is not at least 15 feet of hard packed sand not under high tide inundation, the driving lanes may be temporarily shut down until the high tide recedes. The beach may be closed to driving during this time period; parked vehicles may remain. The beach director and all law enforcement officers shall have the discretion to move these designated areas according to circumstances on the beach.
- (c) When the westerly row of parking has been filled, and provided that tidal conditions permit, the beach director and law enforcement personnel may allow parking on the east side of the traffic lanes. If there is to be a high tide during peak hours of beach use, tidal conditions ordinarily would not be deemed to permit a second row of parking until after the tide has turned and receded far enough to allow beach users a pedes-
