| 18 | WHEREAS, in accordance with the Interlocal Service Boundary Act |
| 19 | chapter 171, part II, Florida Statutes, the city commission of the City of Ormond |
| 20 | Beach approved Resolution No. 2010-131 (Initiating Resolution) on September 7, |
| 21 | 2010, and the county council of the County of Volusia approved Resolution No. |
| 22 | 2010-05 (Responding Resolution) on October 7, 2010, identifying certain issues |
| 23 | along the North U.S. 1 corridor; and |
| 24 | WHEREAS, the city and county met since the approval of the resolutions |
| 25 | to discuss the issues, and negotiated and agreed upon an Interlocal Service |
| 26 | Boundary Agreement (ISBA); and |
| 27 | WHEREAS, the city adopted the ISBA on August 19, 2014; and |
| 28 | WHEREAS, the county council adopted the ISBA on August 21, 2014 by |
| 29 | Ordinance 2014-12; and |
| 30 | WHEREAS, the county council also approved an amendment to the Code |
| 31 | of Ordinances of the County of Volusia to codify transfers of regulatory powers |

related to outdoor entertainment event permitting and itinerant merchant 1 2 licensing in areas identified in interlocal service boundary agreements; and WHEREAS, the ISBA between the county and the city was recorded in 3 4 Official Records of Volusia County at Book 7026 Page 876 on August 28, 2014, 5 pursuant to section 163.01 (11), Florida Statutes; and 6 WHEREAS, after the August 28, 2014 effective date of the ISBA between 7 the county and the city, both jurisdictions identified a need for a transition period 8 for implementing several transfers of regulatory authority; and 9 WHEREAS, the county is the destination for several annual national events which require extensive permitting and licensing, including Biketoberfest 10 11 scheduled for October 16 – 19, 2014; and 12 WHEREAS, planning and permitting for the annual Biketoberfest begins 13 several weeks in advance of the event, and requires timely processing of all 14 permit and license applications to ensure an orderly and safe event for county 15 residents and thousands of visitors: and WHEREAS, the annual Biketoberfest is an important contributor to the 16 17 travel and tourism industry in the county and a safe, efficiently-run event is 18 crucial to its continued success; and WHEREAS, in recognition of the importance of a safe and efficiently-run 19 20 Biketoberfest, and to ensure continuous service to county residents and visitors, 21 the county has agreed to review and issue outdoor entertainment event permits

and itinerant merchant host licenses and merchant licenses on behalf of the city

in the unincorporated areas identified in the ISBA until December 31, 2014; and

1 WHEREAS, the city has agreed to provide city staff to accompany county 2 staff in performance of the day-to-day duties involved in outdoor entertainment 3 event permitting and itinerant merchant licensing to learn about the process. NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL OF 4 5 **VOLUSIA COUNTY, FLORIDA THAT:** 6 SECTION I. The above stated WHEREAS clauses are hereby 7 8 incorporated by reference as if fully stated herein and adopted as findings of fact. 9 SECTION II. Based on the foregoing findings of facts and pursuant to the authority in section 125.66(3), Florida Statutes, the council hereby declares 10 11 that an emergency exists and that immediate enactment of this ordinance is 12 necessary. 13 **SECTION III.** The effective date of Ordinance 2014-13 adopted by 14 the council on August 21, 2014 is hereby delayed until December 31, 2014. SECTION IV. The council hereby ratifies the outdoor entertainment 15 event permits and itinerant merchant host licenses and merchant licenses issued 16 by the county between August 28, 2014 and October 20, 2014 in the 17 unincorporated areas identified in the ISBA. All such permits and licenses shall 18 19 remain in effect until September 30, 2015 and shall be enforced by the City of 20 Ormond Beach after December 31, 2014. 21 SEVERABILITY - Should any word, phrase, sentence, SECTION V. 22 subsection or section be held by a court of competent jurisdiction to be illegal, void, unenforceable, or unconstitutional, then that word, phrase, sentence, 23 subsection or section so held shall be severed from this ordinance and all other 24 25 words, phrases, sentences, subsections, or sections shall remain in full force and
