The Special Session Meeting of the 2013 Session of the Value Adjustment Board was held Monday, October 11, 2013 via teleconference in the Value Adjustment Board Conference Room of the Thomas C. Noting for the record this meeting was a continuation meeting of the 2013 Session of the Value Adjustment Board scheduled for October 7, 2013 in which a quorum of the board was not present. In addition, the signed certifications of taxroll (as mentioned in item 3 of the agenda) contain an October 7, 2013 certification date.

Item 3 on the agenda was the next order of business; being the Certification of the Tax Roll pursuant to Section 193.122, Florida Statutes. - The Real Property Tax Roll as presented by the Property Appraiser to the Value Adjustment Board for 2013 is \$21,851,771,687.
- The Tangible Personal Property Tax Roll as presented by the Property Appraiser to the Value Adjustment Board for 2013 is \$2,322,983,088.
- The Centrally Assessed Property Tax Roll as presented by the Property Appraiser to the Value Adjustment Board for 2013 is \$43,662,229.

A single motion was made by Deborah Denys and seconded by Nick Conte approving each of the three certifications previously presented by the property appraiser, Mr. Morgan Gilreath, Jr. during the meeting of the 2013 Session of the Value Adjustment Board held October 7, 2013. Motion carries.

Agenda Item 4, Board Discussion was the next discussion. The 2013 Final Board meeting was rescheduled from January 6, 2014 to December 9, 2013 as a result of lesser than normal 2013 petition filing.
