The Special Session Meeting of the 2015 Session of the Value Adjustment Board was held October 5<sup>th</sup>, 2015 in Council Chambers of the Thomas C. Agenda Item 3, Approval of Minutes: 2015 Organizational Meeting was the next order of business. Chairperson, Pat Patterson presented the minutes. There were no corrections or additions made. Chairperson, Pat Patterson announced the minutes to stand approved as read.

The next order of business was Item 4, Certification of the Tax Roll pursuant to Section 193.122, Florida Statutes. Chairperson, Pat Patterson requested legal advisement from VAB Attorney, Laurence Bartlett on submitting motions for the certifications. Under legal advisement, individual motions would be required for each certification. The certifications were translated to record by honorable Chairperson, Pat Patterson.

- The 2015 Real Property Tax Roll as presented by the Property Appraiser to the Value Adjustment Board was \$24,670,602,759. A motion approving the Real Property Certification was made by Ray Pennebaker and seconded by Dr. John Hill. The motion carries unanimously.
- The 2015 Tangible Personal Property Tax Roll as presented by the Property Appraiser to the Value Adjustment Board was \$2,392,108,694. A motion approving the Tangible Personal Property Certification was made by Deborah Denys and seconded by Dr. John Hill. The motion carries unanimously.
- The 2015 Centrally Assessed Property Tax Roll as presented by the Property Appraiser to the Value Adjustment Board was \$55,340,478. A motion approving the Centrally Assessed Certification was made by Dr. John Hill and seconded by Deborah Denys. The motion carries unanimously.

The next order of business was Agenda Item 5, which presented the 2015 Final Board Meeting schedule. Honorable Chairperson, Pat Patterson recognized an earlier meeting may be necessary due to the low quantity of petitions filed. Board Member, Ray Pennebaker sought a tentative schedule; Chairperson, Pat Patterson provides direction for the meeting date to be determined upon conclusion of hearings. Property Appraiser, Morgan Gilreath commented on the low number of petitions filed and Save our Homes benefit.

Agenda Item 6 offered other business brought before the board. VAB Attorney, Laurence Bartlett provided verbal resignation following the 2015 session. There was no other business presented.
