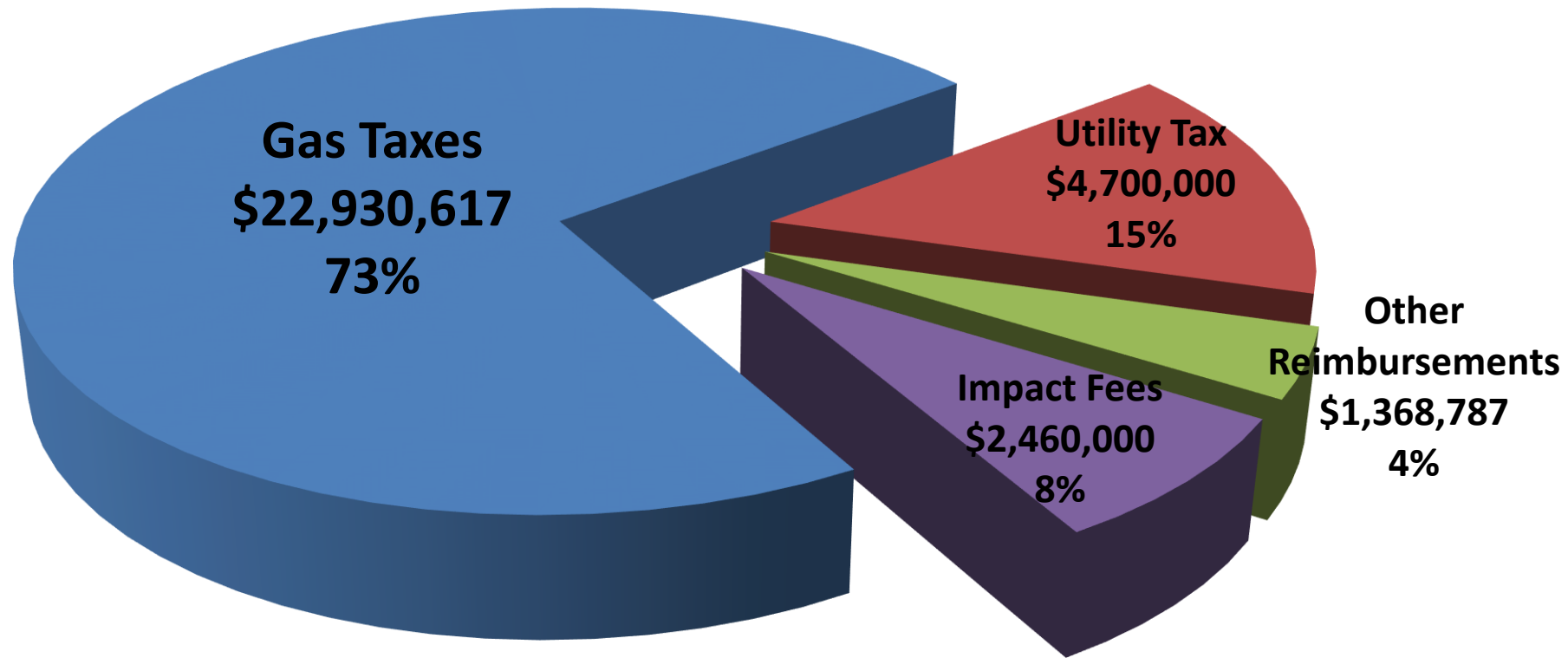

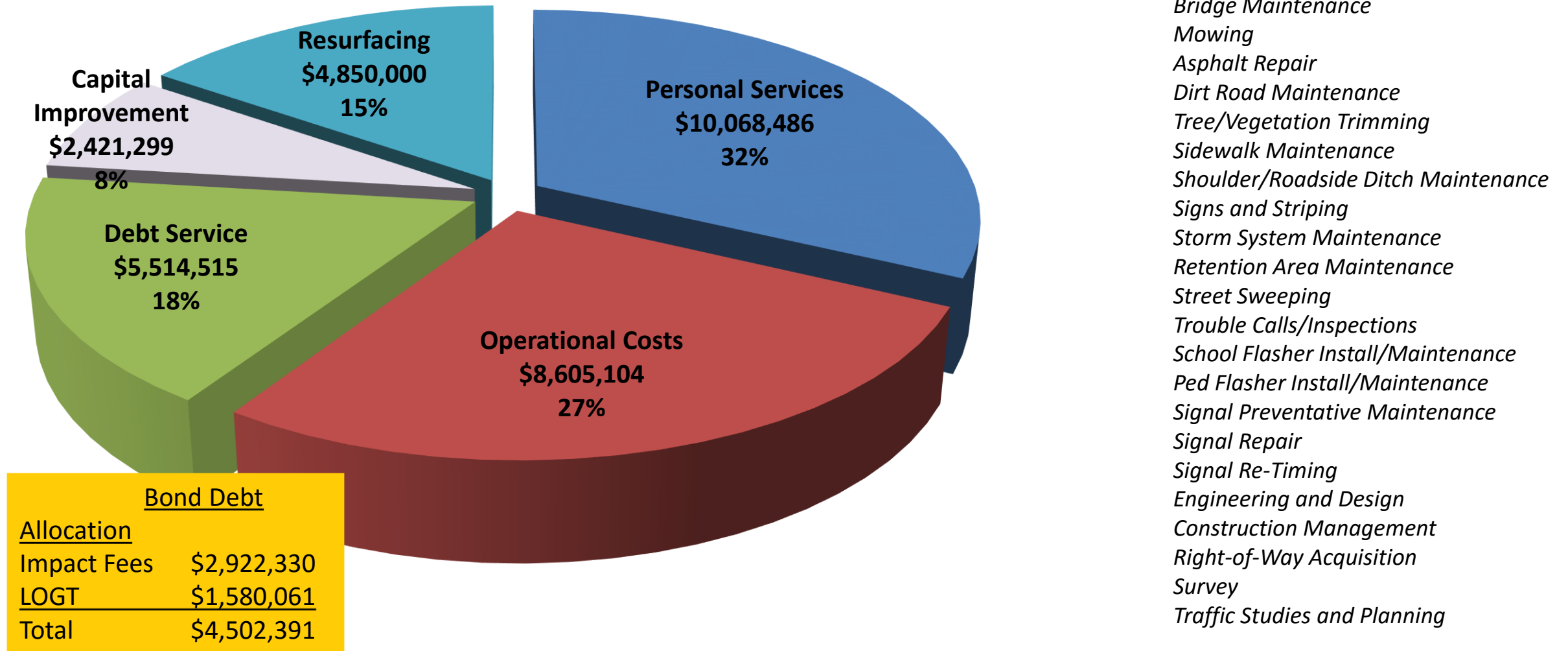

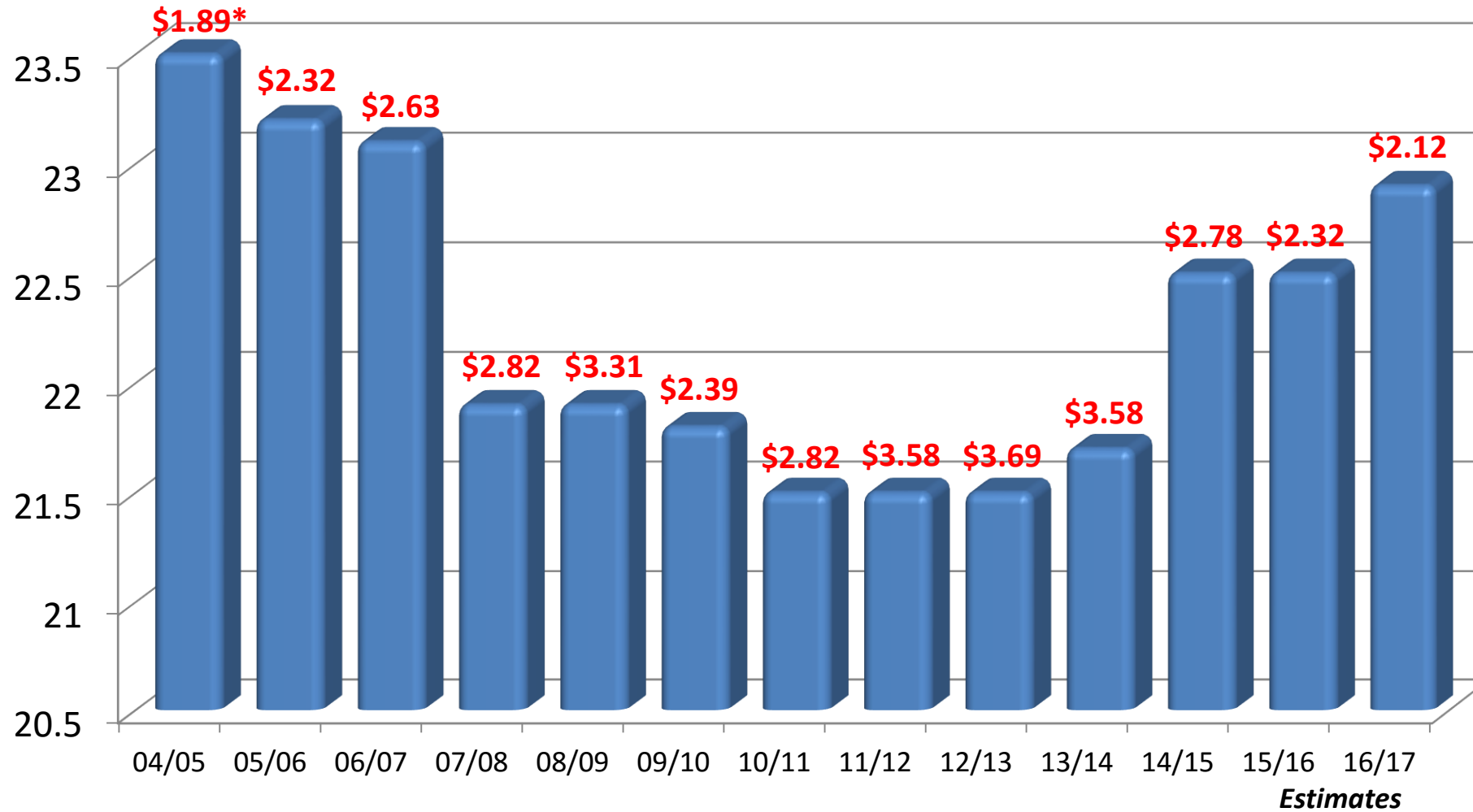
# FY 16/17 Expenses

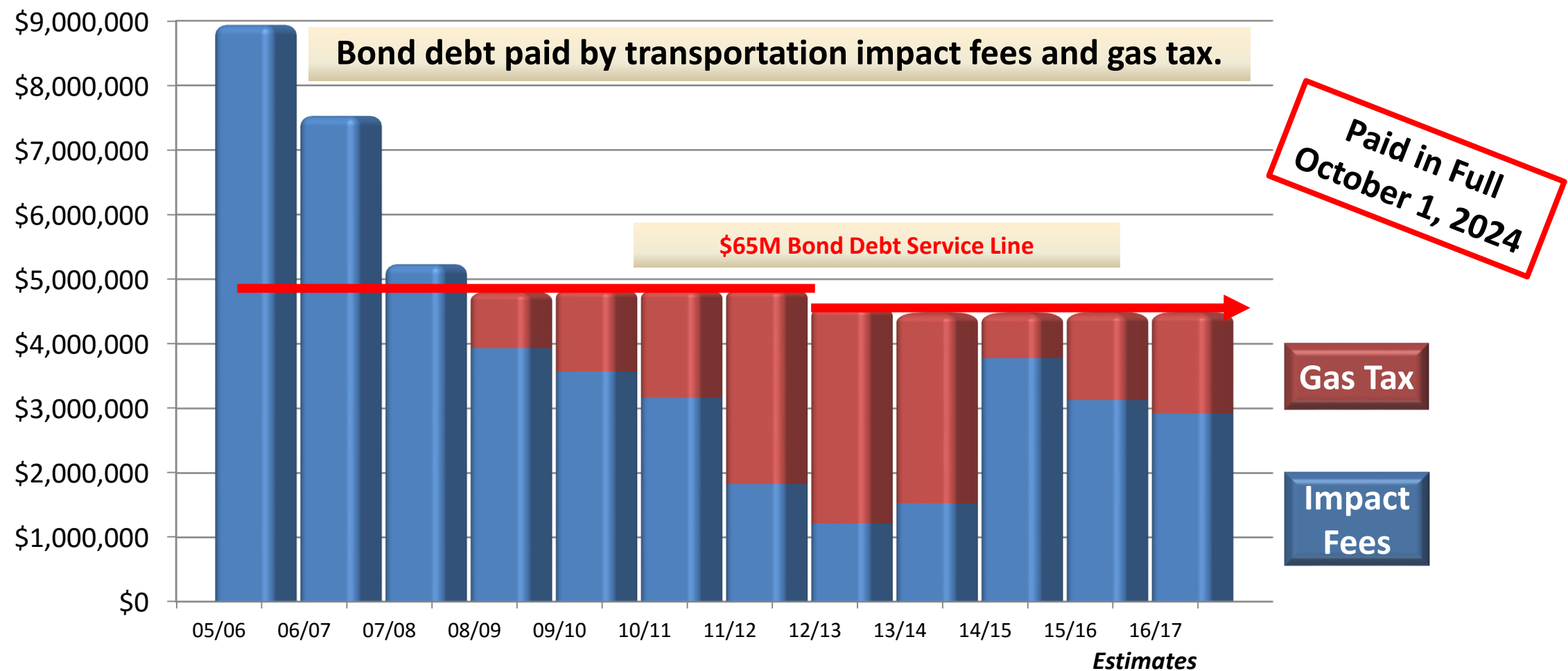

\* Average annual price per gallon

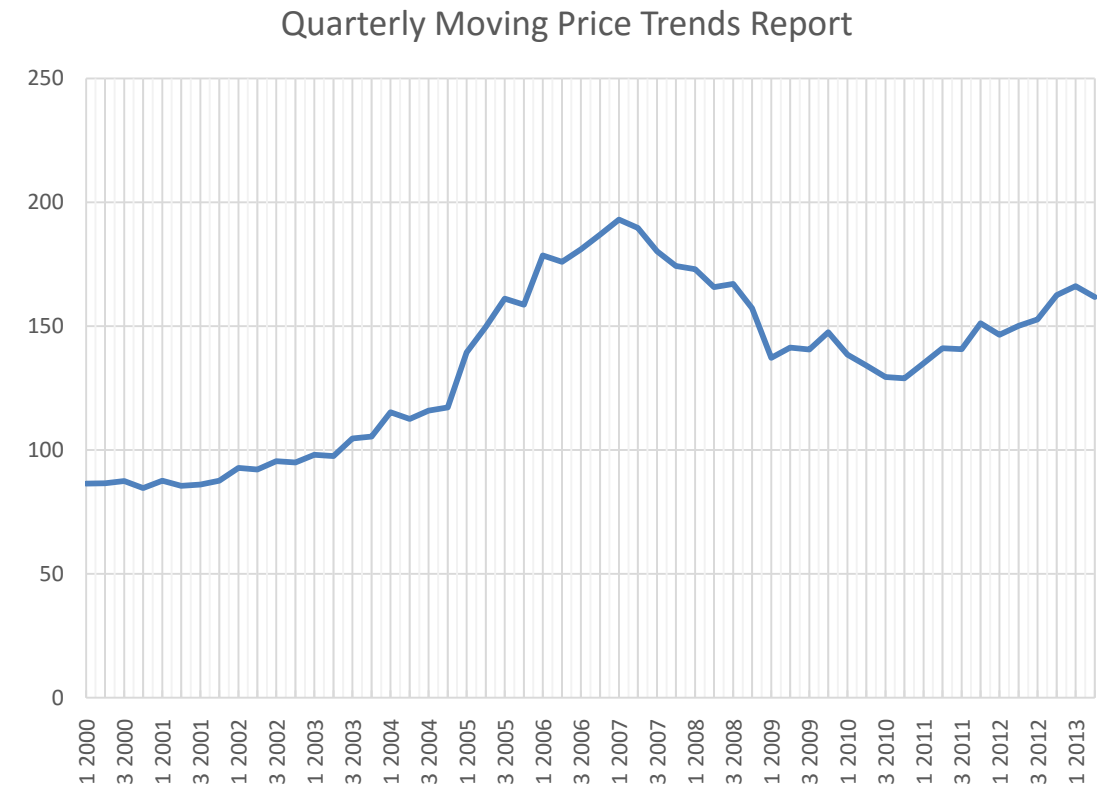
# Road Program Bond Debt

# Inflation Impacts

- Over the same twenty year period that fuel efficiency improved 12%, transportation costs grew by 60%!
- So for every \$1 fuel efficiency gains drained from gas tax funds, inflation drained \$3.50
