#### Call to order

Meeting called to order at 1:40 p.m.

#### Roll call

Ms. Danclair conducted roll call and determined a quorum was present.

#### **Operational Updates**

#### Implementation of LIHEAP Crisis Assistance Limitation

Effective Monday, December 4, 2023, Volusia County Community Assistance reverted to prepandemic seasonal distribution standards, whereby an eligible household may receive a LIHEAP Crisis once every 6 months. This will ensure eligibility with grant guidelines and help increase the number of vulnerable residents that can be assisted. The increased call volume and technological challenges were discussed. Staff are exploring options to resolve the issues with the appointment phone line.

#### Strategic Plan and 2023 Community Action Plan Updates

An annual update to the HSAB Board is required per CSBG organizational standards. The board approved the most recent Strategic Plan on 8/19/2021, and the FY24 Community Action Plan will be presented in this meeting.

Human Services continues utilizing virtual platforms for intake and case management. Clients have the option of calling the appointment phone line to obtain an appointment for assistance, or they can apply for electricity assistance online – both on Monday mornings. This has allowed more clients to be served. However, the demand for assistance remains higher than the funding available, and not all clients in need are able to be served.

The planning and data collection for the next Community Needs Assessment will begin early 2024. In-person focus groups are expected to be held.

Human Services has maintained partnerships with local social service agencies and will continue to strengthen them.

Human Services has implemented the Social Worker in the Library Program. This program allows a social worker to connect members of the community with services and/or resources in the community.

Staff ROMA training was completed in March 2023 and is expected to occur again in 2024.

Staff will continue to monitor customer satisfaction results to stay up to date with best practices and possible improvements.

#### New business

#### Approval of October 26, 2023 minutes:

Ms. Malia called for a motion for approval of the October 26, 2023, board meeting minutes. Mr. Johansson made the **Motion**, **Seconded** by Ms. Watson. The motion passed **Unanimously**.

#### Amend Something Previously Adopted: Meeting Minutes – December 7, 2022
