<u>Call to order:</u> Chair Evans called the meeting to order at 2:09 p.m.

Roll Call: Corry Brown called the role. Waylan Niece and Mark Billings were not present. Sue Odena was not present at the time of roll call, but arrived at 2:11pm. All other members were present and there was a physical quorum.

Item 1 - Election of Chair, Vice-Chair, and Secretary

A motion was made by Ms. Odena to elect Anne Evans as Chair of the Affordable Housing Advisory Committee. The motion was seconded by D.J. Lebo and passed unanimously with seven members present. A motion was made by Ms. Odena to elect D.J. Lebo as Vice-Chair. The motion was second by Peggie Hart and passed unanimously with seven members present. A motion was made by Ms. Odena to elect Waylan Niece as Secretary. The motion was second by D.J. Lebo and the motion passed unanimously with seven members present.

Item 2 – Previous Meeting Minutes

A motion was made by Ms. Odena to approve the minutes from the November 10, 2021 and December 15, 2021 meeting. The motion was seconded by Ms. Lebo and passed unanimously with seven members present.

<u>Item 3- Affordable Housing Plan Outline</u>

Carmen Hall, Community Assistance Director, reviewed the Affordable Housing Plan outline and explained that the document provided was a draft. She asked if there was any feedback or comments that the committee would like to discuss regarding the outline. There was a lengthy discussion about the outline by the AHAC. Chair Evans asked if the

AHAC could have additional time to review the outline more carefully and provide feedback. After discussion amongst the members, they decided to provide comments and suggestions regarding the outline to staff by April 20, 2022 via email.

Ms. Hall explained that the draft Affordable Housing Plan would be presented to the AHAC at the May 18, 2022 meeting. Chair Evans requested that the plan be provided to the AHAC prior to the next committee meeting for review. Ms. Hall confirmed that staff would send out the plan one week in advance, on May 11, 2022. The AHAC discussed ensuring that feedback is received from the community throughout this process, including drafting the plan.

Discussion by board members of matters not on the agenda

Sue Odena provided all members of the public and committee members with a flier for the 2022 Housing Fair and Financial Clinic on Saturday, April 30, 2022.

Items for staff discussion

Corry Brown, Special Projects Coordinator, discussed scheduling future Affordable Housing Advisory Committee meetings. She confirmed that a meeting was already scheduled for May 18, 2022 at 2:00 p.m. at Hope Place. Ms. Brown asked if the new AHAC still wished to meet at Hope Place at 2:00 p.m. and if Wednesdays were still the desired day of the week. The AHAC agreed to hold future meetings at the Emergency Operations Center, including the May meeting. After discussing the times that were most convenient for all members, the AHAC also decided to change the time of future meetings to 3:00 p.m., including the May meeting. Corry Brown recommended having a meeting in June and September, adding additional meetings if needed for the incentive strategy review process. Chair Evans asked each member to send their availability of Wednesdays in June to staff via email no later than April 20, 2022 so that a meeting could be scheduled.
