^{**}Restricted funds were determined to be \$100,000 on June 6, 2018, however it was determined the interest for 2019 - 20 would be rolled into the CD balance. Interest was recorded as income.

B. Review and Adopt Annual Budget – Ms. Gibson commented she prepared the spreadsheet to show 11 years of financial history and proposed budget. She said she had made some projections possible application fee, interest reduction, other fees and said at end of next year fiscal year it may show a loss. Dr. Sharples made a motion to accept the budget. Motion seconded by Mr. Smith and passed by unanimous voice vote. (Budget attached for reference)

Dr. Sharples made mention that last December discussion was held about the excess funds and what they could be used for but the county attorney's office did not return with information. It had been discussed of using funds for "ready to go" projects, small business development, etc. For example, property surrounding the airport those dollars could be used to expand and get to a point of entitlement for a piece of property at the county level. Mr. Manning stated that Assistant County Attorney Laura Coleman will be looking into the funds and will be working with the IDA in the future. The IDA is a considered a special district and is restricted of what funds can be used for but research needs to be done to determine also whether dollars can be used not only for public lands but private as has been discussed. The restricted \$100,000 needs to be looked into as well per discussion.

Ms. Van Eckert will be the point of contact with the county attorney's office and CFO's office for allowable uses of current and restricted dollars. Some years back out of an abundance of caution the \$100,000 was restricted because of an inability to track its origin. Mr. Hall and Mr. Coolidge should be involved with the county attorney's office for further questions.

Ms. Jamison questioned about limiting the fund availability for public lands only. She said southeast Volusia had a satellite manufacturer, rocket manufacturer that was interested in a specific piece of land due to its location but the land was privately held. She questioned how any of the funds could be used for private. Comment was made that these were public dollars and probably would be spend for public use but will be determined at a meeting in the near future. November was mentioned as the Authority will need to elect officers for 2021. This was acknowledged.

VI. New Business

A. Chairman Stark introduced Helga van Eckert, recently appointed the county's Economic Development Director. Ms. Van Eckert gave a short intro of her background and previous positions and introduced a new employee to Economic Development, Katrina Friel who will be assisting the authority in the future.
