MEETING

Minutes of June 20, 2005 meeting

A meeting of the Emergency Medical Services Trust Fund Advisory Board was held on June 20, 2005, at the Emergency Operations Center, Daytona Beach, Florida. Matt Zavadsky called the meeting to order at 3:35 p.m.

Welcome and introductions:

The Chair opened the meeting with introductions.

AED Placement Requests:

Matt Zavadsky gave an update on the available 70 AED's, 35 from Volusia County EMS trust fund and 35 from the American Heart Association's grant received from the United Way, and described each agency and the quantity of defibrillators that each agency has requested.

Of the 192 requests for AED placement, 40 being from privately owned facilities, the members agreed that some agencies, more than others, are in a position to purchase their own units through Volusia County's price agreement with Zoll.

Matt Zavadsky advised that the Heart Association has approximately \$29,000 available to help launch a Public Awareness program to educate all people through billboards, etc. on the importance of AED's in all businesses and homes. Nothing further was discussed on that topic.

An open discussion ensued with the following AED placements agreed upon by all members:

- 20 units going to Volusia County Beach Patrol Vehicles

- 15 units going to schools designated as Hurricane Shelters as follows:
 1. 1 unit to Campbell Middle School, Daytona Beach, FL
 2. 1 unit to DeBary Elementary School, DeBary, FL
 3. 1 unit to DeLand Middle School, Deland, FL
 4. 1 unit to Friendship Elementary School, Deltona, FL
 5. 1 unit to Timbercrest Elementary School, Deltona, FL
 6. 1 unit to Deltona Lakes Elementary School, Deltona, FL
 7. 1 unit to Spirit Elementary School, Deltona, FL
 8. 1 unit to Discovery Elementary School, Deltona, FL
 9. 1 unit to Forest Lake Elementary School, Deltona, FL
 10. 1 unit to Sunrise Elementary School, Deltona, FL
 11. 1 unit to Hinson Elementary School, Holly Hill, FL
 12. 1 unit to Volusia Pines Elementary School, Lake Helen, FL
 13. 1 unit to Pine Trails Elementary School, Ormond Beach, FL
 14. 1 unit to Pathways Elementary School, Ormond Beach, FL
 15. 1 unit to Horizon Elementary School, Port Orange, FL

- 10 units to Dr. John Shedd – Volusia County Medical Director to be used for AED loaner program. This program will provide a loaner AED to at risk post-operative cardiac patients for home use.

- 2 units to Edgewater Fire Department command vehicles
- 1 unit to the Center for the Visually Impaired, Daytona Beach, FL
- 1 unit to the United Methodist Children’s Home, Deltona, FL
- 1 unit to the City Nurse, Daytona Beach, FL
- 20 units to Law Enforcement Offices as follows:
 1. 2 units to Edgewater PD
 2. 2 units to New Smyrna PD
 3. 1 unit to Ponce Inlet PD
 4. 1 unit to Oak Hill PD
 5. 2 units to Orange City PD
 6. 2 units to Ormond Beach PD
 7. 2 units to Port Orange PD
 8. 1 unit to South Daytona PD
 9. 7 units to the Volusia County Sheriff’s Office
