Planned Unit Development Applications do not follow this schedule; applicants will be notified when they will be scheduled for PLDRC.

Applications for items to be heard by the Planning & Land Development Regulation Commission (PLDRC) shall be submitted to the Growth and Resource Management Department, Building and Zoning Division. Staff has 3 days from the date of submission to determine if the application is sufficient. If the application is determined to be insufficient and the applicant does not provide the corrected or additional information within 3 days after the deadline date, said application will not be considered "filed" for the purpose of processing nor placed on the PLDRC agenda.

PLDRC hearings are held in the County Council Meeting Room of the Thomas C. Kelly Administration Center, 123 W. Indiana Avenue, DeLand, commencing at 9:00 a.m.

Rezoning and Special Exception applications require a *first* public hearing by the PLDRC and *second* public hearing by the County Council. Variance requests require a single public hearing by the PLDRC.

The applicant-requested Continuance Fee is **\$149.00** (*Resolution 2003-58*)
