**I. CALL TO ORDER**

**II. APPROVAL OF MINUTES**

**A. JAIL REPORT – Cindy Clifford**

Ms. Clifford reported that the total population today is 1,546 including 263 females.

**B. CJIS REPORT – Evelyn Thompson**

Ms. Thompson reported that the CJIS project is on schedule. All activities are on target. The CJIS steering committee is schedule to meet next week on the 7<sup>th</sup>.

IV. OLD BUSINESS

A. Chet Bell – Stewart Marchman Center

Mr. Bell provided handout information regarding the Criminal Justice, Mental Health and Substance Abuse Reinvestment Grant. He advised that the deadline for the grant is 11/01/07. He has been in contact with Matt Greeson, Deputy County Manager and Dona DeMarsh, Volusia County Community Services, regarding this grant. Mr. Greeson advised he would be working with Public Protection on the county side.
