Urgent Care Centers vs. Hospital Emergency Rooms

The emergency room should be used for emergencies only. Going to an emergency room, instead of an urgent care center, for <u>non-emergency medical conditions</u> can cost you more money in copays and/or coinsurances!

EMERGENCY ROOM

\$65 Copay

Average Plan Cost for Emergency Room visit: \$2,261.37

URGENT CARE CENTER

\$50 Copay

Average Plan Cost for Urgent Care visit: \$196.67

IS IT AN EMERGENCY?

If you, your spouse or child, get sick or injured, your first instinct is to go to the emergency room right away or call 911. These are good instincts, in an emergency, but many people use the emergency room when it is not an actual emergency.

What is considered an emergency?

In general, an emergency condition is one that can permanently impair or endanger the life of an individual. Some examples of conditions that require emergency medical care include:

- Severe chest pain or pressure
- Uncontrolled bleeding
- Coughing or vomiting blood

- Difficulty breathing or shortness of breath
- Sudden dizziness, weakness, or change of vision
- Severe or persistent vomiting or diarrhea
- Changes in mental status, such as confusion

What is considered an urgent medical condition?

Urgent medical conditions are ones that are not considered emergencies, but still require care within 24 hours. Some examples of such conditions include:

- · Sprains and strains
- Moderate back problems
- Mild to moderate asthma attacks
- Bleeding/cuts -- not bleeding a lot but requiring stitches
- Eye irritation and redness
- Mild to moderate vomiting
- Fever or flu
- Severe sore throat or cough
- Skin rashes and infections
- Urinary tract infections
