



Basis for Evaluating Grant Opportunities

- Supports or enhances Volusia County initiatives
- Meets administrative and program funding criteria
- Funding for local match requirement is available
- ➤ Funding for on-going costs after grant period expires can be maintained
 - > FTE's and additional Operation & Maintenance costs



Process for Grant Application

- Departments monitor and seek out grant opportunities
 - > Federal Clearinghouse
 - State Catalog
 - Grant Agency Notices
 - Professional Membership Emails
- Grant applications and award contracts are presented to County Manager/Council for approval
- ➤ 177 grants being monitored Expend approximately \$35M a year



Snapshot of FY2013


- > \$35.5M grant funding reported
 - ▶ 68% federal funding
 - 24% state funding
 - ➤ 1% local funding
 - > 7% other funding (primarily program income)

Major grants are within:

- 40.1% Community Services
 - > SHIP, Home, CDBG
- > 27.8% Votran
- ➤ 19.3% Airport
- 5.9% Public Works
 - > FDOT roadway projects




FY13 Revenues by Source
