



<p>Summary/Highlights: The two-year terms of board members on the Animal Control Board commenced April 1, 2013. One position has not been filled.</p> <p>APPOINTMENT METHOD: District 2. Each district council member shall make one nomination of an elector from within the county. The county chair and the at-large member shall make two nominations of an elector from within the county. Nine members serve two-year terms. Membership of the animal control board may include, but are not limited to:</p> <ul style="list-style-type: none"> (1) a licensed veterinarian (2) a humane society representative (3) a cat owner (4) a member of a kennel club (5) a hunter (6) a county citizen from an unincorporated residential area (7) a livestock owner (8) a county citizen from an unincorporated agricultural area (9) a county citizen from an unincorporated area with an expressed interest in animal issues <p>Applications have been received from the following:</p> <ul style="list-style-type: none"> - Maria Avellino (citizen from unincorporated area)

The animal control board makes recommendations on the county's animal control ordinance, animal control legislation and regulations. The board recommends, regulates and sets standards of procedure countywide for the collection, care, custody and disposal of animals.

Meetings are held quarterly on the second Tuesday of the month, but not more than six times annually, unless otherwise needed.

Recommended Motion: One appointment from a designated category (if possible) for the two-year term expiring March 31, 2015.

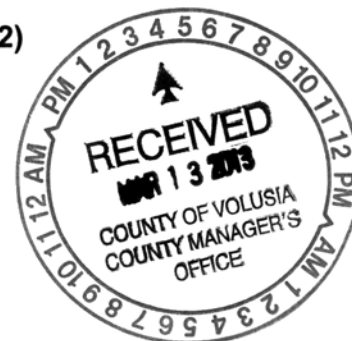
