

Applications are needed for the below boards due to vacancies and/or upcoming expiring terms. Pursuant to Resolution 2009-101, "Good Standing" checks will be completed on each applicant. Individuals cannot serve on more than two (2) boards at a time. In addition, an individual cannot serve on more than one board that constitutes a county office (as noted below).

Boards that need applications:

- Animal Control Advisory Board (1 position; Chair)
- Code Enforcement Board (2 positions; District 5 and At-Large member)
- Contractor Licensing and Construction Appeals Board (7 positions, Each District member; At-Large member and Chair)
- Cultural Council (1 position; Chair East-side)
- Educational Facilities Authority (1 position; Any Council member)
- Volusia Growth Management Commission (1 positions; Any Council member)
- Health Planning Council (1 position; Any Council member)
- Historic Preservation Board (2 positions; District 4, Chair East-side)

Animal Control Advisory Board (Chairs appointment)

- **Term:** Expires on March 31, 2021
- **Members:** 9
- **Nomination method:** Each district member shall make one appointment. The County Chair and the at-large member shall each appoint two members.
- The member does not have to reside in the Council member's district.
- **Qualifications:** Member must be registered to vote in Volusia County.
The Animal Control Board shall include, whenever possible:
 - a licensed veterinarian
 - a humane society representative
 - a cat owner
 - a member of a kennel club
 - a hunter
 - a county citizen from an unincorporated residential area
 - an owner of livestock
 - a county citizen from an unincorporated agricultural area
 - a county citizen from any unincorporated area with an expressed interest in animal issues.

Code Enforcement Board (At-Large & Lowry)

- **Staggered terms:** 2 members that expire November 18, 2021; 2 members that expire November 18, 2022; 3 members that expire November 18, 2023.
- **Members:** 7
- **Nomination method:** Each district member and the at-large member shall make one appointment. The County Chair shall make two appointments.
- Member does not have to live in the council member's district.
- **Qualifications:** Member shall be an elector of the county. The membership of the code enforcement board shall, whenever possible, include an architect, a business person, an engineer, a general contractor, a subcontractor and a realtor.
- *Serving on this board constitutes a County office. No Person may serve on more than one of these boards. No person shall hold at the same time more than one office under the government of the state and the counties and municipalities therein.*
- *Expires 11/18/2021*

Contractor Licensing and Appeals Board (Post) (Must meet qualifications)

- **Term:** Expires on March 31, 2022
- **Members:** 7
- **Nomination method:** Each Council member shall make one nomination.
- The member does not have to live in Council member's district.
- **Qualifications:**

The CLCA shall be composed of the following:

- (1) A general contractor or other contractor who is registered or certified under F.S. §§ 489.105(3)(a) through (c).
- (2) An electrical contractor qualified under article III, division 3, [section 22-141 et seq.] of the code.
- (3) A plumbing contractor qualified under article III, division 2, [section 22-111 et seq.] of the code.
- (4) A mechanical or heating, air conditioning, refrigeration, or ventilation contractor ("HARV") qualified under article III, division 2, [section 22-111 et seq.] of the code.
- (5) A registered engineer under the laws of the state.
- (6) A registered architect under the laws of the state.
- (7) A consumer representative who may be any resident of Volusia County that never has been a member or practitioner of a profession regulated by the CLCA or a member of any closely related profession.

No elected official, appointed state, county or municipal office holder, member of two or more other county boards or commissions, or employee of county government, shall be appointed to serve on the CLCA. All members of the CLCA, except for the consumer representative, shall be licensed in this state and actively engaged in the profession they represent on the CLCA. All members shall be voters registered in the county.

- *Serving on this board constitutes a County office. No Person may serve on more than one of these boards. No person shall hold at the same time more than one office under the government of the state and the counties and municipalities therein.*

Cultural Council (East-side Brower)

- **Term:** Expires on March 31, 2021
- **Members:** 9
- **Nomination method:** Each district member shall make one appointment. The County Chair and the at-large member shall each appoint two members (one from the Eastside and one from the Westside.).
- The member must live in that Council member's district.
- **Qualifications:** The member must be registered to vote in Volusia County.

Educational Facilities Authority (Any Council member)

- **Staggered terms:** 1 term expired March 1, 2021; 1 term expires March 1, 2022, 1 term expires March 1, 2023, 1 term expires March 1, 2024, 1 term expires March 1, 2025.
- **Members:** 5
- **Nomination method:** Appointments are made on a countywide basis by the entire Council. Any Council Member may make the appointment.
- The member does not have to reside in the Council member's district.
- **Qualifications:** Each member of the Authority shall be a resident of the county and at least one of which shall be a trustee, director, officer or employee of an institution for higher education located in the county.
- *Serving on this board constitutes a County office. No Person may serve on more than one of these boards. No person shall hold at the same time more than one office under the government of the state and the counties and municipalities therein.*

Volusia Growth Management Commission (Any Council member) Remainder of a term to end 6/30/2023)

- **Staggered terms:** 12 members that expire June 30, 2021; 9 members that expire June 30, 2023.
- **Members:** 23
- **Membership:** There shall be one voting member from each municipality within the County and five voting members from the unincorporated area of the County. The appointment of each voting representative shall be made by the governing body of each respective jurisdiction. The Volusia County School Board, the St. Johns River Water Management District, and the Volusia County Business Development Corporation shall each designate one nonvoting member to serve on the commission. The term of office of the commission members shall be fixed by the rules of procedures of the commission but shall not exceed four years.
 - 5 Volusia County Representatives (Any Council member).
- **Nomination method:** Appointments are made on a countywide basis by the entire Council. Any Council member may make the nomination for the Volusia County representatives.
- **Member does not have to live in the council member's district.**
- **Qualifications:** Five voting members shall be from the unincorporated area of the County. The member must be registered to vote in Volusia County
- *Serving on this board constitutes a County office. No Person may serve on more than one of these boards. No person shall hold at the same time more than one office under the government of the state and the counties and municipalities therein.*

Health Planning Council (Any Council member)(remainder of a term to expire 10/1/2022)

- **Term:** Expires on October 1, 2022
- **Members:** 12 (2 Volusia County Consumers)
- **Nomination method:** Appointments are made on a countywide basis by the entire Council. Any Council Member may make the appointment.
- The member does not have live in the Council member's district.
- **Qualifications:** Each member of the Health Planning Council Any person eighteen (18) years of age or over who resides or has his/her principal place of business in the health service district.

Historic Preservation Board (Post & Brower (East-side))

- **Term:** Expires on March 31, 2021
- **Members:** 9
- **Nomination method:** Each district member shall make one appointment. The County Chair and the at-large member shall each appoint two members (one from the Eastside and one from the Westside.).
- The member does not have live in that Council member's district.
- **Qualifications:** Members may be appointed from either or both the incorporated or unincorporated areas of the county. Board members may be professionals from the disciplines of architecture, history, architectural history, archaeology, anthropology, cultural geography, planning or other related disciplines or citizens who have demonstrated special interest, experience or knowledge in history, archaeology, architecture or related disciplines.
- *Serving on this board constitutes a County office. No Person may serve on more than one of these boards. No person shall hold at the same time more than one office under the government of the state and the counties and municipalities therein.*

Housing Finance Authority of Volusia County (Any Council member)

- **Staggered terms:** 1 member expires October 15, 2021; 2 terms expire October 15, 2022; 1 member expires October 15, 2023; 1 member expires October 15, 2024
- **Members:** 5
- **Nomination method:** Appointments are made on a countywide basis by the entire Council. Any Council Member may make the appointment.
- The appointee does not have to reside within the Council member's district.
- **Qualifications:** Not less than a majority of the members shall be knowledgeable in one of the following fields: labor, finance, or commerce.
- *Serving on this board constitutes a County office. No Person may serve on more than one of these boards. No person shall hold at the same time more than one office under the government of the state and the counties and municipalities therein.*
- *Expires 10/15/2021*

Human Services Advisory Board (Any Council member)

- **Term:** Expires on September 30, 2021.
- **Members:** 15
5 are appointed by County Council, 5 are elected by the community and 5 are representatives of community organizations.
 - Mr. Robins currently serves as the 5th member.
- **Nomination method:** Appointments are made on a countywide basis by the entire Council. Any Council Member may make the appointment.
- The member does not have live in that Council member's district.
- *Expires 9/30/2021*

Personnel Board (Any Council member)

- **Term:** Expires on December 31, 2021
- **Members:** 5
- **Nomination method:** Appointments are made on a countywide basis by the entire Council. Any Council Member may make the appointment.
- The member does not have live in that Council member's district.
- **Qualifications:** Each member of the personnel board shall be a qualified voter of the county, shall be known to be in sympathy with the merit principle as applied to the merit system, shall neither hold nor be a candidate for any public office or employment and shall not be a member of any local, state or national committee of a political party or an officer in any partisan political club or organization.
- *Serving on this board constitutes a County office. No Person may serve on more than one of these boards. No person shall hold at the same time more than one office under the government of the state and the counties and municipalities therein.*
- *Expires 12/31/2021*

SunRail Customer Advisory Committee

- **Members:** 2 from Volusia County
- **Nomination method:** Appointments are made on a countywide basis by the entire Council. Any Council Member may make the appointment.
- The member does not have to reside in Council member's district.
- **Qualifications:** The member must ride SunRail at least 3 days a week. The SunRail CAC is made up of two advisors from each of the local funding partners.
- **The SunRail Customer Advisory Committee is not a County Board.**
