Board meetings are open to the public. Pursuant to s. 286.0105, Florida Statute, if a person decides to appeal any decision made by the VAB with respect to any matter considered at any meeting or hearing, he or she will need a record of the proceeding, and that, for such purpose, he or she may need to ensure a verbatim record of the proceedings is made, this includes the testimony and evidence upon which the appeal is to be based.

### NOTICE UNDER THE AMERICANS WITH DISABILITIES ACT (TITLE II)
