Business Services

Information Technology

 Central Florida GIS – Information Technology coordinated and managed a meeting of the Central Florida Geographic Information Systems users group. This meeting brought together 101 people from counties and cities across Central Florida. Discussions included data sharing and collaboration, process automation, and the role local governments will play in the 2020 Census. Special interest groups were formed to discuss recreational trails and Next-Generation 911 systems.

Revenue



- Director Confirmed Craig Baumgardner was confirmed as Revenue Director at the May 7 County Council
 meeting. Some of Craig's top priorities for the division are to lead a smooth transition to an elected tax
 collector's office, should that come to pass, and the implementation of an electronic line queuing system
 in all Revenue offices, a continuance of the ongoing technology modernization initiative in Revenue. The
 system will be both an efficiency for the division and a convenience for the public.
- Delinquent Advertisement A list of delinquent taxpayers was published in the May 13, 2019 edition of the News Journal. Subsequent advertisements are scheduled for May 20 and May 27, in accordance with Florida Statute. The advertisements lead up to the eventual sale of tax certificates (liens) on any accounts that remain unpaid as of May 31, 2019.

Community Services

Agriculture Extension (AG Center)

- Food and Nutrition Program (FNP) began their end of school year celebrations with students participating in their garden lessons. Fourth grade students at Read-Pattillo Elementary chopped up vegetables to be toppings on their English muffin pizza's.
 - The students were able to try different vegetables like bell peppers, onions, mushrooms, tomatoes and spinach. With the exception of mushrooms, these students have been growing these vegetables during the school year and learning about the importance of eating them.
- FNP program Assistant Patti Young provided a cooking demonstration and discussed how to eat healthy away from home with participants at Daytona Beach Regional Library's "How-To Fest".
 - There was about seven participants who attended the lesson. Patti talked with participants about how to look for healthy food choices on menu's and provided tips when eating out.

Community Assistance

- Housing & Grants
 - Provided three second mortgage loans to first-time homebuyers to assist with the purchase and closing costs associated with home purchase.
 - Since the start of this fiscal year, using State Housing Initiatives Partnership (SHIP) and HOME Investment Partnership Program (HOME) grant funds, a total of 43 loans were made to Volusia County households with low to moderate income to help make affordable homeownership a reality.
 - The Volusia County Affordable Housing Advisory Committee's 2019 Report on Affordable Housing Incentives Strategies was submitted to, and accepted by, County Council.
 - County Council approved the adoption of four of the eleven affordable housing incentive strategies recommended by the AHAC in their report.
 - The AHAC is an advisory board required by the State Housing Initiatives Partnership (SHIP)
 act and must review and report on affordable housing incentive strategies
 - Staff collaborated with the Volusia County Health Department to pursue new marketing strategies and hold an extra summer camp scholarship intake site on May 6, 2019.
 - Resulted in hundreds of new clients being introduced to the program and issuing an additional \$37,275 in scholarship vouchers to families.
 - A total of 1,303 applications have been processed and 1,235 children have been offered scholarships.
 - Staff will continue to process applications that are mailed in or submitted in person until no funding is available of the program comes to an end.
 - The City of DeLand awarded the Spring Hill area Dr. Joyce M. Cusack Resource Center construction project to a contractor on May 6, 2019.
 - Volusia County Community Development Block Grant (CDBG) funds are being used in conjunction with city and CRA resources to create the new facility which will include a multipurpose room, kitchen, computer lab, and health room.



- The building and site work construction contract was awarded at \$1,012,293. The CDBG allocation for the project is \$437,658.
- Construction is expected to begin in June.
- Staff will work with city staff throughout construction to monitor federal grant compliance and ensure that construction workers on site are paid properly, as this project is subject to federal prevailing wage requirements.
- The Neighborhood Center of West Volusia (NHCWV) is under contract for the implementation of the Emergency Solutions Grant Program (ESGP) and has begun accepting referrals for the homeless prevention and rapid re-housing activities.
 - The homeless prevention program assists households who are at imminent risk of homeless with short-term rental assistance, security deposits, utility assistance, utility deposits and case management.
 - The rapid re-housing program assists households who are literally homeless with short-term rental assistance, security deposits, utility assistance, utility deposits and case management.

Section 8

 In April 2019 an additional 12 families secured housing and began receiving rental assistance through the Section 8 program. In addition, 22 families were provided vouchers to identify and secure housing.

Florida Department of Health in Volusia County (FDOH-Volusia)

- Update: Hepatitis A outreach continues to target high-risk populations
 - As of May 24, 89 cases of hepatitis A have been confirmed in Volusia County this calendar year. In all
 of 2018, five hepatitis A cases were confirmed in the county.
 - The Volusia County Health Department (CHD) continues to focus on reaching three high-risk populations by offering vaccinations and prevention education.
 - The high-risk populations are: drug users and residents of drug addiction treatment facilities, the homeless population, and inmates at County and State correctional institutions. Staff who work in these facilities or with these populations are included in outreach activities.
 - Volusia CHD staff continue to meet with municipal and County public safety responders, correctional facilities, local hospitals and treatment facilities to share outreach materials.
 - Volusia County is one of 25 Florida counties that has been identified as a high-risk county for hepatitis A activity. High-risk counties have five or more cases with active transmission within the last 50 days within a high-risk group.
 - The Hepatitis A information line is available to answer questions from the public about Hepatitis A
 activity in Florida from 8 a.m. to 5 p.m., Monday through Friday. The toll free number is 1-844-CALL DOH (844-225-5364).
 - Written questions may be submitted to HepA@flhealth.gov.
 - A webpage dedicated to Hepatitis A information is live on the State's website at http://www.floridahealth.gov/diseases-and-conditions/vaccine-preventable-disease/hepatitis-a/index.html.
- Community leaders to discuss Community Health Needs Assessment May 24
 - Key representatives from key community sectors have been invited to serve as a leadership team member as part of Volusia County's Community Health Needs Assessment (CHNA).
 - The leadership team meeting will be held from 9 a.m. to 11 a.m., Friday, May 24, in conference room 516-C at the Volusia CHD, 1845 Holsonback Dr., Daytona Beach.
 - Spearheaded by the County of Volusia, Volusia CHD, AdventHealth, and Halifax Health, the CHNA is a collaborative effort that engages key stakeholders and community members in identifying priority health issues for focused work over the next three years.
 - At the meeting, leadership team members will:
 - Review collected data detailing risk factors, quality of life, mortality, morbidity, and social determinants of health for Volusia County
 - Identify health priorities that will serve as the foundation of the collaborative Community Health Improvement Plan.

It is the oldest, largest and finest drill and ceremony competition held annually and brings over 4,000 room nights to the area. On May 6, Embry Riddle Aeronautical University had a graduation ceremony that attracted approximately 6,000 people.
- The next week's events included Stewart- Marchman Act's annual conference, Who is Jay?, for 400 people; the Daytona Area Convention of Narcotics Anonymous DACNA, with 200 hotel rooms and 1,100 participants, the Central Florida Herbalife Meeting for 250 people and over 5,000 attended Graduation ceremonies for Daytona State College on May13.
- This week will finish with the AdventHealth Leadership Conference for 250 people on May 15 and the Joseph Volleyball Academy FC Power League Volleyball Championships, May 17-19, with an anticipated attendance of 9,600 competitors and attendees with 1,100 room nights. This championship is a junior girls' volleyball tournament for ages 12-18 and for some teams will serve as a season-ending event and for others a tune-up for both Girls AAU and USA Volleyball Junior National Championship events.

Capital Projects update

- A1A Marquee: All of the concrete columns and beams have been poured and forms removed. Final concrete finishing work is underway. Work will begin on the green top cap and the installation of the signs very shortly. Project remains on schedule.
- Arena Barrel Roof/ Parking Garage Roof: The arena barrel roofs and all six parking garage roofs are complete.
- Arena Floor Box Replacement: A design proposal was received from Halkins & Ogle Architects. A task
 assignment is working its way through the approval process and is scheduled to be on the June 4, council
 agenda.
- Arena Elevator Modernization: Only one bid was received and that vendor took exception to the insurance requirements. Purchasing is working with the contractor and the consultant to finalize the contract.

 Architects. A task assignment is working its way through the approval process. The first step of the design



- process will be to access the condition of the existing moveable wall system to determine if replacement is necessary or just refurbishment.
- Exterior Door Replacement: Design team has meet with their door/hardware consultant and are refining the scope of work for this project.
- Garage Decking: Task Assignment approved for ARC Engineering to begin preparing bid documents for project. Kickoff meeting was held on April 16. ARC's structural engineer has completed his inspection.
 Drawings are being created and specifications are being developed.
- Garage Elevator Vestibules: Bid was awarded for replacement of the vestibules on level six of the garage. Contract and purchase order to contractor are ready to be issued. Working with contractor to establish a notice to proceed date.
- LED Lighting: A kickoff meeting with TLC Engineering was held on April 24. A project schedule was created to
 have all of the design work completed this fiscal year with bidding and construction to take place right after
 the new fiscal year starts. Background drawings have been sent to TLC. The design team is working through
 the as-built drawings of the Ocean Center and documenting current conditions.

Mosquito Control

Operations

- Field inspectors are conducting surveillance and treatment of mosquito larvae by ground and boat due to large amounts of recent rainfall. Adult populations are being monitored for planning ultra-low volume (ULV) truck operations in the targeted areas.
- As part of our Integrated Pest Management Program, staff is reviewing the modes of action of our current products and planning field efficacy trials for testing local mosquito populations.
- Mosquito Control is in the process of interviewing student interns to work in our surveillance program for the upcoming season. The students will be setting and collecting mosquito traps, identifying



mosquito samples, maintaining sentinel chicken flocks, assisting with efficacy testing of local populations, and data management.

Road & Bridge

- Construction Maintenance
 - Road and Bridge Ditch Maintenance crews repaired a significant washout to the roadside ditch along Pioneer Trail, near Airport Road in the Port Orange Area. This work was initiated based on a Supervisor's routine asset inspection.
 - Road & Bridge Maintenance Crews completed asphalt patch repairs to Tymber Creek Road at multiple locations in the Ormond Beach area. This work was in response to a citizen request.
 - Road and Bridge Traffic Operations Crews completed the installation of roadway striping and raised pavement markers on Marsh Rd and Old Daytona Rd in the DeLand area.
 - On Tuesday, May 21st, Road & Bridge Maintenance Crews will begin mowing the unopened portion of the right-of-way along the west side of LPGA Blvd. from US-92 to Tournament Dr. This work, weather permitting, is expected to last approximately 2 weeks.

Water Quality Grant

On May 10, the Indian River Lagoon (IRL) Council Board of Directors approved funding up to \$100,000 for the engineering design of a regional stormwater treatment facility for the Gabordy Canal, a primary conveyance waterway that discharges into Mosquito Lagoon. This project was identified in the Mosquito Lagoon Reasonable Assurance Plan (RAP) and will reduce the nutrients thereby improving the water quality of baseflow and stormwater discharging to Mosquito Lagoon. The stormwater treatment facility will be co-located with the stormwater facility required for the 10th Street Widening Project. Funding will be provided through the IRL council's FY 2019-20 budget cycle. Formal execution of the contract agreement between the County and the IRL Council is expected later this summer.

Solid Waste

- Disposal Activities: In the past two weeks, the Tomoka Farms Road Landfill received and processed over 14,560 tons of garbage, 5,484 tons of construction and demolition debris, and over 4,823 tons of yard waste. The tonnage processed is equivalent to the weight of 1,554 semi-tractor trailers.
- Recycling Education: On Apr. 29, Solid Waste staff attended the Ormond by the Sea Town Hall meeting and discussed general recycling information and the new education campaign, "Back to Basics", with the residents.

Funding will be provided through the IRL Council's FY 2019-20 budget cycle. Formal execution of the contract agreement between the County and the IRL Council is expected later this summer.
