### **COMMUNITY SERVICES**

Library Services: The Edgewater Public Library reopened on April 26, following a three-week closure for renovations. **Environmental Management:** The MSC has the approval to begin a "soft" reopening of the facility. The reopening plan includes operating hours from 10 a.m. to 4 p.m. on Fridays and Saturdays, starting May 7. MSC staff will use the month of May to evaluate measures put in place to mitigate against COVID risks. News releases or social media posts are not planned so as to keep attendance to a minimum.

The annual St. Johns River Cleanup is underway. Due to COVID precautions, this year's event is being held from April 24 to May 1. Participants are picking up trash on their own over that time period. So far, 52 volunteers have participated, logging 125 hours and removing 600 pounds of trash from the river. Participants will earn a beach towel and tote, which will be distributed May 1. ### **OCEAN CENTER**

*Events:* The Ocean Center hosted the State of the County Address, a lunch and presentation for approximately 300 people, which as our largest catered event since before Covid-19. On April 28, staf began the move-in process for the National High School Drill Team Championships (NHSDTC). The NHSDTC remains the oldest, largest and finest all-service drill & ceremony competition annually assembled in Daytona Beach. Sponsored for decades by the U.S. Army Cadet Command, "the Grand Nationals" as this legendary event has grown to be recognized features school-aged drill & ceremony units of all ability levels and from all of the four branches of the military. This event runs through May 1. It brings with it over 4,000 attendees, and an expected 4,000 hotel room nights. This event, as for all events, masks are required and social distancing is enforced.

### **PUBLIC WORKS**

**Coastal**: Contractors working for the Coastal Division are planning to complete all on-beach construction this week at Dahlia Beach Park and Edwin W. Peck, Sr. Park in Daytona Beach Shores, Plaza Blvd Beach Ramp in Daytona Beach, and the 18<sup>th</sup> Avenue Dune Walkover in New Smyrna Beach. With the official start of sea turtle nesting season beginning on May 1, contractors will have all concrete sheet-pilings for the seawalls and all timber posts for the dune walkovers installed and equipment off the beach prior to May 1. **Engineering & Construction:** Lemon Bluff Marina construction progress continues. Floating docks have been installed and completion of the storm system is expected in the coming days. **Mosquito Control:** Mosquito Control is conducting our annual evaluation of historical mosquito trap locations in regards to new housing developments and population changes. Mosquito traps are routinely set throughout the county to monitor adult mosquito counts and the data used to make operational decisions. As land use changes, it can be necessary to retire certain trap sites and/or add new trap sites to ensure efficient data for field operations. **Road & Bridge:** Drainage task team crews are completing a project to remove overgrown vegetation and debris within an open channel canal system known as C-36. The C-36 canal system is located in the Pioneer Trail/Tomoka Farms Road area, and is an essential stormwater drainage asset, particularly during heavy rain events. **Solid Waste:** The Volusia County Adopt a Road Program is a litter reduction campaign designed to remove litter and debris from Volusia County roads and improve the quality of the environment. Community volunteers sign up to adopt one mile of county roadway and perform litter clean up to four times a year. In 2020, COVID-19 limited these volunteer efforts; however, in 2021, cleanups are back under way. Since January there have been 57 volunteer cleanups, collecting 291 bags of litter and 36 bags of recyclable materials. This program is a partnership between volunteers, businesses and/or organizations and the county working together in efforts to manage litter control along roadways and to keep Volusia County beautiful.
