COMMUNITY SERVICES

Community Assistance: Community Assistance is accepting applications for the Edward Byrne Memorial Justice Assistance Grant (JAG) Countywide program for FY 2022-23. The county anticipates \$139,627 being available on a competitive basis to Volusia County nonprofit organizations and local cities that do not receive a direct annual allocation of JAG funding. Eligible federal purpose areas include law enforcement; prosecution and court; prevention and education; corrections and community corrections; drug treatment and enforcement; planning, evaluation and technology improvement; crime victim and witness programs; and mental health and related law enforcement and corrections programs. COUNTY MANAGER'S OFFICE

Community Information: Staff attended the unveiling ceremony of the Mary McLeod Bethune bronze statue in Daytona Beach on Aug. 18. Photographs were taken and a special video that included unique drone footage was created and posted on the County's social media platforms. Preparation efforts are underway for the upcoming ribbon cutting for the Chuck Lennon Hiking Trail on Aug. 27. Staff coordinated with the Coastal Division on the reef deployment, being carried out with the County, the Coastal Conservation Association, Shell USA and OUC. Staff interviewed Supervisor of Elections Lisa Lewis on the County's radio program; a video carve out was posted on Facebook. FINANCE

Information Technology: Improvements have been made to the sea turtle dashboard, providing more information about the sea turtle nesting season. The latest version of the application is also more responsive to different screen sizes, making information easier to navigate on mobile phones. The Geographic Information Systems team has Implemented new Image Server software, providing a new set of tools for using aerial, drone and satellite photography. New workflows have been implemented to allow users to capture images using a drone and integrate these images with other GIS datasets. Developed a new web-based form allowing municipalities to coordinate with the Property Appraiser's Office on proposed annexations. This will help eliminate situations where cities and the County coordinate on an annexation, only to find that the proposal doesn't meet the Appraiser's requirements. Administration: The second public workshop to discuss the results of the 2022 impact fee study was held on Aug. 17. For more information, contact Clay Ervin at cervin@volusia.org.

Environmental Management: The Sea Turtle Program continues to monitor a record number of sea turtle nests laid on County beaches this year. The total nest count is up to 1,396. The dashboard at www.volusiaseaturtles.org has been updated to show the numbers of nests that have been evaluated and a total hatched egg count that is updated as survey crews enter data. The hatched egg count is over 42,000 to date. There have been 50 sea turtle nest disorientation events this season. Two properties have been referred to the Code Enforcement Board and will have hearings to impose fines, if not found in compliance. Over 70 other properties are in some stage of the compliance and enforcement process, with many reaching voluntarily compliance.

Washback Season officially started on Aug. 1. Fresh seaweed has been washing onto our beaches almost daily. While no washback sea turtles have been recovered yet, Beach Safety and Watchback Watcher Volunteers are conducting surveys as needed prior to beach opening to public drivers. Mosquito Control: Mosquito Control is continuing to respond to an increase in sentinel chicken arbovirus activity of West Nile virus. Sentinel chickens are used to monitor mosquitoborne virus activity of endemic arboviruses and do not become sick, nor can they spread the virus to other mosquitoes. Additional surveillance through mosquito trapping is being conducted to monitor Culex mosquito populations and pool mosquitoes for virus testing. Treatments are being scheduled based upon surveillance data. Mosquito Control is reminding the public through social media to practice the "5D's" to protect themselves from mosquitoes.
