*Information Technology:* Staff kicked off a project to automate and improve the business workflow processes and data gathering necessary for the court's first appearance system. ### **GROWTH & RESOURCE MANAGEMENT**

Environmental Management: Environmental staff presented information about the water quality of our springs to the Natural Resources Leadership Institute on Feb. 16 and 17, including a tour of Blue Spring State Park. Environmental Permitting (EP) YTD inspection numbers are up 33% compared to this time last year. EP staff has conducted 6,354 Inspections and reviews this FY. In FY 20-21, EP staff conducted 18,005 inspections and reviews, an increase of 40% over the FY 19-20. EP inspections have increased by 97% since FY 16-17. The Sea Turtle Habitat Conservation Program is planning a Lighting Expo, which will be held on May 27 at the Daytona Beach Shores Community Center. The Expo will provide vendors, displays and presentations about the sea turtle lighting ordinance and ways that properties can get fixtures or assistance with coming into compliance. Staff is also working with the Archie Carr Center for Research to provide compliant fixtures at no cost to properties in Volusia County that do not comply with the ordinance. *Traffic Engineering:* Traffic Engineering staff attended the Spring Hill Community Redevelopment Agency (CRA) meeting recently and discussed the county's process of developing a Residential Traffic Control Plan (RTCP). The Spring Hill CRA requested the county to work with the City of DeLand in developing a RTCP. Water Resources and Utilities: Working in cooperation with the Florida Dept. of Environmental Protection, staff has secured a \$5.5 million grant for design and construction of advanced wastewater treatment upgrades at the Southeast Regional Water Reclamation Facility in Oak Hill. The upgrades will enable the facility to achieve new water quality goals established under the North Indian River Lagoon Basin Management Action Plan. In addition to treatment process upgrades, plant capacity will also be expanded from 600,000 to 1,200,000 gallons per day.
