COMMUNITY SERVICES

Resource Stewardship: The ECHO advisory committee will hold an Environmental Projects Workshop at 1 p.m. July 14 in the Council Chambers to hear ideas and recommendations as to how to increase the number of funded environmental projects over the next 20 years. The land management team was selected to become a partner involved in the Upland Ecosystem Restoration Project (UERP) which is a partnership between Tall Timbers Research Station, numerous state and federal agencies including the University of Florida, and numerous conservation organizations. The County managed 8,090 acre Lake George Forest and Wildlife Management Area (LGF-WMA) has been selected to be a focal area in central Florida. Becoming a partner makes the County eligible to receive cost-share and grant funds to support and supplement the ongoing upland restoration efforts occurring on the LGF-WMA. Environmental Management: The countywide sea turtle nest count has reached a new record high with over 1,021 nests laid this season. The last record high season was a total of 984 nests in 2019. Since nesting will continue through September, the final count will likely far exceed the 2019 count. Nests are now starting to hatch, so it important to follow all of the lighting requirements to help hatchlings reach the ocean. Staff has opened over 60 lighting enforcement cases so far this season. Shorebird chicks are still being seen throughout County beaches and islands. A press release was issued on July 1, to remind people about the birds and how to play safe. The message seems to have worked because all nesting activity is still underway in all of the previously known locations. The monofilament recycling program is looking for new adopters in the New Smyrna Beach area. Over 20 bins are up for adoption. Coastal: In preparation for the Independence Day weekend, the Coastal Division added additional port-o-lets at Mary McLeod Bethune Park and staged extra dumpsters throughout the Coastal parks. During the holiday weekend, janitorial contract staff continuously traveled to coastal restroom facilities for cleaning, replenishing supplies, and assisting with litter pick up. Contracted beach maintenance staff walked the beach and coastal parks picking up trash and operated additional trash carts emptying trash cans. Coastal staff, toll attendants, beach maintenance, and beach concessionaires offered complimentary trash bags to patrons to encourage responsible litter disposal. During the July 5 cleanup, 28.26 tons of garbage, including 1.3 tons of recyclables, was collected. The total of 28.26 tons is up from last year's tonnage of 20.3. Road & Bridge / Water Resources and Utilities: The Florida legislature adopted a 20-year stormwater and wastewater needs analysis for all counties, municipalities, and special districts. For the first cycle of reports, local governments submitted their reports by June 30, and the Public Works Department will compile the local reports, including our own, and submit them to the Office of Economic & Demographic Research (EDR) by July 31, 2022. EDR will then publish an analysis in the 2023 edition of the Annual Assessments of Florida's Water Resources and Conservation Lands.
