Environmental Management: Pollution Control Manager Tom Carey has been elected Chairman of the Indian River Lagoon Council's Management Board. The Board consists of stakeholders at all levels: federal, state, county, city, and citizen to ensure that local issues are managed by bringing all stakeholders to the table to work out solutions that are consensus-driven and based on sound science. The Board advises and recommends to the Indian River Lagoon Council on financial, technical and administrative matters. On May 5, the Volusia County Marine Mammal Stranding Team assisted the Florida Fish and Wildlife Conservation Commission (FWC) and SeaWorld with the release of a 1,500 lb. male manatee named "Yago" at Blue Springs State Park. Yago was rescued in Brevard County in February his year. On May 6, the team assisted FWC with the rescue of a female manatee suffering from a boat strike in the Indian River Lagoon area of Volusia County. The animal was captured and transferred to SeaWorld rehabilitation for care. On May 10, the team assisted with the release of a pregnant manatee named "Paprika" at Blue Springs State Park. She was rescued from the St. Johns River suffering from a boat strike. Sea turtle nesting season began May 1, and as of May 11, we have 28 nests laid on county managed beaches.
