Enviromental Management: On Nov. 21, the MSC admitted a juvenile Hawksbill sea turtle that stranded in New Smyrna Beach. Named "Timon," the sea turtle is on a treatment plan for infection and passed a small amount of plastic. Timon is showing signs of improvement daily but is still in the early stages of rehabilitation. Listed as endangered, Hawksbills are found mostly on coral reefs in the Atlantic, Pacific, and Indian Oceans. Hawksbills are rare in Volusia County, with the last juvenile admitted in 2008. Beach Safety: To continue providing a superior level of service, Beach Safety will again seek reaccreditation through the Commission for Florida Law Enforcement Accreditation (CFA) this week. This week, a team of independent assessors from the CFA will once again review Beach Safety Ocean Rescue's policies, procedures, management and operating practices and, pending clearance, will re-accredit the agency for another three years.
