AVIATION & ECONOMIC RESOURCES

Daytona Beach International Airport

Enviromental Management: The Marine Science Center's animal hospitals had a very busy 2020. The turtle hospital admitted 156 adult and sub-adult sea turtles, which set a record number of intakes during a year. The turtle hospital also admitted 427 hatchling and washback sea turtles, and 147 miscellaneous reptiles. The turtle hospital recorded its 25,000th intake during 2020. The bird hospital admitted 1228 birds during 2020 that comprised 127 different species. The bird hospital has received over 18,000 intakes since opening in 2005.
