#### **COMMUNITY SERVICES**

Community Information: Staff coordinated with Parks, Recreation and Culture, Public Works, Resource Management and FDOT with the Jan. 21 ribbon-cutting event for the opening of the new 2.9-mile extension of the Spring-to-Spring trail in DeBary. The event was well attended by many trail blazers, local residents and dignitaries. ## **GROWTH AND RESOURCE MANAGEMENT**

**Administration:** The Land Development Regulation affordable housing subcommittee meeting was held on Jan. 19 at the Emergency Operations Center.

**Environmental Management:** Environmental Permitting (EP) YTD inspection numbers are up 36.8% compared to this time last year. EP staff has conducted 4,732 inspections and reviews this fiscal year (FY). In FY 20-21, EP staff conducted 18,005 inspections and reviews, an increase of 40% over FY 19-20. EP inspections have increased by 97% since FY 16-17.

Water quality sampling staff from Environmental Management completed monthly sampling of Mosquito Lagoon. Water clarity was typical for this time of year. Though the water had a greenish tint, chlorophyll readings were low and do not indicate an algae bloom.

The Manatee Festival is Jan. 22 and 23 at Valentine and Blue Springs State Parks. Staff will provide an educational table. Manatee Watch Training is in February and there are two opportunities to receive training. For more information, contact Jennifer Winters at jwinters@volusia.org.

Sea turtle Habitat Conservation Plan and Beach Safety Division staff met with members of the Daytona Chamber of Commerce for a roundtable discussion on beach safety and environmental questions. The primary topics of discussion were the sea turtle lighting regulations, homeless and vagrancy problems, hotel rights to provide beach equipment for guests and concessions, the beach app, and partnership ideas to educate hospitality staff and guests.

## **OCEAN CENTER**

**Events:** On Jan. 22, the Ocean Center will wrap up the Florida Fire Chiefs Foundation's, Fire-Rescue East Conference, as they begin their move-out. This conference brought about 1,500 guests, and approximately 1,500 room nights. On Jan. 23, we will host the Volusia County Teacher of the Year Celebration, which is expected to bring in 900 guests. **Emergency Management:** Emergency Management, in partnership with the cities, continues to support COVID-19 testing and vaccination efforts while closely monitoring impacts of the Omicron variant, which has reached its spike. Five mobile testing sites remain operational in Daytona Beach at City Island and the Ocean Center, Deltona at Dewey O. Boster Park, the New Smyrna Beach City Gym, and the Volusia County Fairgrounds. Emergency Management staff participated in regional, state, and DOH COVID19 situation meetings throughout the week. Numbers for testing are expected to decrease and additional resources are available from FDEM. We also welcomed six new interns into their Emergency Management program this week. **Solid Waste:** The Solid Waste Division maintains fourteen (14) used motor oil drop off sites where residents are encouraged to recycle used motor oil. Water Resources and Utilities: During calendar year 2021, a total of 2,868 continuous water use and 645 high consumption alert calls were made to customers. The utilities support team contacts customers advising of continuous 24-hour use (indicating possible leaks) and unusually high consumption during a 72-hour period (indicating inefficient irrigation use).
