**Marketing & Customer Experience:** Staff is preparing for the third round of DAB Cares Kits assembly. To date, staff has distributed approximately 7,000 cares kits to departing passengers. **Votran:** Votran Fixed Route Operator Ted Glenn won 2<sup>nd</sup> place for the Florida Public Transportation Associations' Operator of the Year. He was awarded a plaque during a virtual ceremony late last week. This award recognizes an outstanding operator whose service has enriched and enhanced public transportation in their community.

#### **COUNTY MANAGER'S OFFICE**

Community Information: Community Information is coordinating with Public Works on the scheduling of a ribbon-cutting to mark the grand opening of the Public Works NE service facility; the event is tentatively scheduled for early January. Staff is working with Economic Development and DeLeon Springs company, Sparton, to coordinate an on-site event in recognition of Sparton's upgrade of its wastewater treatment facility with the assistance of the County's water quality infrastructure grant program; Sparton is the first recipient of the grant program. Staff are working with Solid Waste for the creation of a unique graphic for the upcoming Strive to Thrive tire amnesty event event in December for DeLand's Spring Hill. Coordination efforts are beginning for the 2021 State of the County Address. Community Information's production team will be transitioning to a new studio in November, currently under construction in the southwest basement area of the Historic Courthouse. ## **PUBLIC PROTECTION**

Animal Services: Director Adam Leath will be putting his expertise to work with a national organization devoted to maintaining the highest professional standards in the field of animal welfare and public safety. On Oct. 9, Mr. Leath was selected to serve as a director on the board of the National Animal Care & Control Association (NACA). Mr. Leath was among five new directors elected by NACA's membership to the organization's board. The all-volunteer board of directors helps guide NACA's activities, which include professional training and a certification program for animal care workers. Subsequently, on Oct 10, he was also elected as Treasurer for this same board.

For the first time, the Volusia County Animal Care Clinic was open for business on a Sunday. On Oct 11, clinic staff spayed/neutered 19 cats as part of the Trap/Neuter/Return Program. These free-roaming cats received the spay/neuter surgery, ear tip, rabies and FVRCP vaccination, and a dose of topical flea medication.
