AVIATION & ECONOMIC RESOURCES

Daytona Beach International Airport

Operations: The airport's annual Part 139 inspection was Friday, Oct. 30. It was a virtual administrative inspection, where required FAA records and documentation were uploaded to the FAA inspector and included a three-hour zoom call with the inspector to answer any questions. On Oct. 28, the airport coordinated with US Secrete Service, Volusia Sheriff's Office and Air Traffic Control for a VIP movement (Donald Trump Jr.) at the airport's fixed-based operator, ATP. Economic Development: Staff continues to process small and home-based business grants. To date, 3,230 small business grant application have been received with 2,627 checks distributed totaling more than \$7.95M. GROWTH & RESOURCE MANAGEMENT

Environmental Management: The MSC Education Department has begun testing its virtual school field trip programs with Volusia County schools. The pilot programs have reached four different classrooms with over 70 students. Teacher feedback has been positive, and the Education Team looks forward booking virtual school field trips soon. On Oct. 28, Environmental Management staff joined project partners: Stetson University, East Central Florida Regional Planning Council, and Sea Grant to facilitate the Collaborating for Resilience workshop. The workshop invited stakeholders to provide input to further two grant funded resilience initiatives, Stetson University's Sea Grant "Optimizing coupled human and natural system benefits for public land acquisitions in the east central Florida coastal zone," and Volusia County's Resilient Volusia Phase 2 - Adaptation Action Areas. This workshop, which started the stakeholder input in these initiatives, included discussion about land conservation and establishing priority areas and strategies to further resiliency efforts in the County. The Town of Ponce Inlet Planning Board reviewed the proposed site plan for the new MSC modular bird hospital at their Oct. 27 meeting. The board unanimously recommended approval to the Town Council, subject to extension of the roof overhang to match the existing buildings on the property. OCEAN CENTER

Events: For the first time, the Ocean Center recently hosted Diamond's Fall Classic Cheer and Dance Competition comprised of ~1,000 attendees and athletes. Social distancing and safety measures are implemented and being enforced for all events. The group had a great experience with seeking interest in returning next year. The Ocean Center will be hosting the Daytona Beach Police Department for training Nov. 4 - 5. We continue partnering with the Department of Public Protection with the distribution and storage of PPE for businesses and frontline workers. We also continue to collaborate with Halifax Urban Ministries for assembling and distribution of resources and food, an operation that has been in place since May, Nearing October's end, HUM will have distributed over 50K bags of food through this COVID Response Feed-A-Family session in Volusia County. PUBLIC PROTECTION

Emergency Medical Services: EMS will be taking delivery of eight new ambulances which were ordered this past fiscal year, with ten more new ambulances approved by the County Council this fiscal year. This newer fleet will optimize the county's EMS operations by providing power-assist/power-loading stretchers, as well as creating more cab and box space for field staff, of whom warmly welcome these new state-of-the-art vehicles as their mobile offices. PUBLIC WORKS

Coastal: State law requires the Florida Department of Environmental Protection (FDEP) to develop and adopt Inlet Management Plans (IMPs) for improved inlets such as the Ponce de Leon Inlet. IMPs describe strategies for mitigating erosion that may be caused by inlets on adjacent beaches. FDEP's Ponce de Leon Inlet Management Plan is scheduled to be publicly posted the week of Oct. 26 for a 21-day public comment period. The County will place an informational advertisement in the News Journal the weekend of Oct. 31 and the IMP is anticipated to be discussed at the Nov. 10 County Council Meeting. Traffic Engineering: The Transportation Map Series comprehensive plan amendments will be heard before the Planning and Land Development Regulation Commission (PLDRC) and the County Council in the next few months. As part of the amendments, County staff is proposing the addition of a thoroughfare "Needs List." If adopted, four currently proposed thoroughfares on the Thoroughfares Roadways Map would be placed on the "Needs List" (and removed from the Thoroughfare Roadways Map) due to their forecasted needs beyond 2035, high costs, and lack of secured right-of-way. They include the I-4 Frontage Road, Madeline Ave. extension, LPGA Blvd. extension and the Westside Connector. In the future when the County is able to complete alignment studies the "Needs List" roads could be moved back to the Thoroughfare Roadways Map.
