COMMUNITY SERVICES

The departments of Community Services and Public Protection came together to serve alongside 15 agencies to provide support and housing relocation services to 31 households from a local hotel that will be condemned in early November. Divisions included Community Assistance who took the lead in coordination, Library Services, Resource Stewardship - UF/IFAS, Votran, Veterans Services, Animal Services and Emergency Management. We brought together these agencies to help these folks in a time of need, they included Career Source, One Voice for Volusia, DCF (five tables with a variety of services - including Access which provided over 15 households with immediate benefits), HUM, First Step, Neighborhood Center, Homeless Coalition, Early Learning, Halifax Health, Healthy Start, Family Heath Source and the Health department. We gave out countless bags of food, boxes of MREs, masks, and hand sanitizer. Four pack and play cribs, vet care, dog food and animal crates were provided as well. Animal Services has spayed or neutered and provided general well-being vet care to several of the animals living at the hotel this past week. We gave out 17 new library cards were issued and 13 hotspots. We also started the process for 5-7 families with disabilities to apply for special Section8 vouchers. The Monoclonal Antibody Infusion testing site active in Ormond Beach has conducted the treatment to a total of 4,302 patients in Volusia County, but may be reevaluated by the State in the near future. The mobile testing sites in Daytona Beach and Deltona continue to operate with a possible New Smyrna Beach site opening. The Daytona Beach site will likely be relocated to the Daytona International Speedway in the near future to increase visibility.
