**Mosquito Control:** Mosquito Control is reminding residents to protect against mosquito bites by wearing personal protection. This includes protective clothes and EPA approved repellents, which are the best way to prevent mosquito bites. Repellents used should have an active ingredient, such as DEET, picaridin, oil of lemon eucalyptus, or IR3535. #### Water Resources and Utilities

Through 10 months of the current fiscal year period (Oct 2021 – Jul 2022), combined potable water production averaged 4.238 million gallons per day throughout the county's six utility service areas. This represented a 1.5% increase compared with the prior fiscal year. Meanwhile, reclaimed water production for irrigation use averaged 1.709 million gallons per day, representing a 10% increase compared with the prior fiscal year.
