## **GROWTH & RESOURCE MANAGEMENT**

**Environmental Management**: The Volusia County Marine Mammal Stranding Team was dispatched to Blue Spring State Park on Dec. 19 to assist with the release of a manatee named, "Miles." Miles had been rescued in 2016 as an orphaned calf, and again in early 2022 and treated for starvation. Miles was released directly into the Manatee Sanctuary at Blue Spring State Park where the natural spring keeps the water warm enough to sustain our manatees through the winter. We expect hundreds of manatees to congregate in this area over the next few weeks and months.

Volusia County Environmental Management and Save the Manatee Club partnered for an outreach event to promote safe boating on the intracoastal waterway. Brochures and educational materials were distributed by Volusia County volunteers to local marinas and boat rental facilities. The partnership is planning a second event in the spring.

The Marine Science Center (MSC) is planning a Community Conversation at the Ponce Inlet Community Center on Jan. 11 at 6 p.m. to discuss the Marine Science Center's capital improvement plans. The meeting will start with a brief presentation about the animal hospital, education, and guest services programs, and then attendees will be able to visit stations that detail each program at the

**Planning & Development Services:** Wexford Reserve Unit 2 (111 single-family lots) in Ormond Beach passed all final infrastructure inspections. Single-family homes can now receive a Certificate of Occupancy. Halifax Plantation Unit II, Section O, Phase 4, a 68-lot single-family residential subdivision, was recorded Dec. 19. The subdivision infrastructure is currently undergoing final inspections and all building permits will have a Certificate of Occupancy hold until those final inspections are passed.

*Fire Rescue:* A New Hire Academy will start on Jan. 9, 2023, for five new firefighters. The Battalion Chief promotional process will be concluded the week of Dec. 19 for three candidates. Once candidates have completed the process, they will meet with the fire chief for a Fire Chief Interview. The second grant funded aerial class is being conducted this week. This class will introduce participants to classroom lectures and practical exercises on the uses of aerial apparatus, including the recognition of hazards which may be present during aerial operations, tactical and safe placement of aerial apparatus, and principles of water supply during aerial operations. ## **PUBLIC WORKS**

**Coastal:** Coastal staff coordinated with contractors to repair and install beach gates at Harvard Dr Beach Approach in Ormond Beach, which were damaged during Hurricane Nicole. Coastal staff also completed installation of a new set of stairs at 7th Ave in New Smyrna Beach. Coastal trades workers repaired the split-rail fencing at Glenview Off Beach Parking, as well as installed new side boards on the walkover at Via Madrid in Ormond. Trades are continuing to repair, demo, and coordinate the removal of other damaged segments at repairable walkovers throughout



the County in an ongoing effort to re-gain public beach access at our beach front parks, accesses, and off beach parking lots.

**Mosquito Control:** As weather becomes cooler, mosquito production slows down but does not completely stop. Surveillance continues throughout the winter to monitor populations, and treatments are conducted as needed, weather permitting. The division is currently conducting maintenance and required annual calibration for all equipment to ensure proper function. Field staff are also receiving routine training on the safe operation of equipment, calculating application rates, and proper material handling. **Traffic Engineering:** Since the beginning of Dec. 2022, Traffic Engineering has received an influx of Transportation Impact Analyses. Within this timeframe, there have been five (5) TIA Methodologies and nine (9) TIAs reviewed, which is significantly higher than normal. Per the River to Sea TPO guidelines, TIAs are required when projected daily traffic volumes for a new development exceed 1,000 daily trips.
