Environmental Management: Green Volusia facilitated a weeklong Youth Resilience Academy for the Spring Hill Lacey Family Boys & Girls Club from June 7-11. Mosquito Control: Mosquito Control uses mosquito fish for biological control of mosquito larvae as a key part of our Integrated Pest Management (IPM) program. They are the ideal solution for managing mosquitoes in abandoned or neglected swimming pools in the community. Road & Bridge: Drainage crews are installing a stormwater drainage system along Seabreeze Drive in Ormond-By-The-Sea. The project is one of several targeted within the North Peninsula area that will improve stormwater drainage conveyance and water quality before its discharge into the Halifax River. Solid Waste: The pre-construction meeting for the Class III disposal stormwater improvements will be held on June 17. The project includes an updated grading plan that will change the current terrace stormwater system to a conventional stormwater system that includes the construction of 6,300 linear ft. of perimeter ditch surrounding the class III cell to collect stormwater runoff. It also includes expansion of an existing wet detention stormwater pond for storage & treatment. The improved system will meet current FDEP requirements and will improve the water quality that is eventually discharged to onsite wetlands. Operationally, we will be able to utilize the 90,000 cy³ of soil excavated from the pond expansion for daily and intermediate waste disposal cover needs. Traffic Engineering: Staff are preparing and submitting a scope and fee estimate for a Pedestrian Evaluation Study at the intersection of S. Atlantic Avenue and Hiles Boulevard. This study will determine whether pedestrians are utilizing the crosswalk correctly and whether drivers are complying when the flashing pedestrian signs are activated. Water Resources and Utilities: Utilities management team and supervisory staff completed vulnerably assessments of its water treatment plants, distribution systems, and administrative operations in accordance with state and federal guidelines.
