Environmental Management: The Sea turtle Habitat Conservation Plan (HCP) program is hosting a Sea Turtle Lighting Expo at the Daytona Beach Shores Community Center from 1 to 7 p.m. May 27. The Expo will educate residents, managers and regulatory officials about the lighting ordinance and options for coming into compliance while providing safely lit properties and roadways. Water Quality staff conducted routine sampling from the southern portion of the St. Johns River (including Lake Harney), as well as Lake Ashby, Deep Creek, and various streams. Water levels were up in the river due to rainfall received during the month.

Mosquito Control: Mosquito Control keeps a record of the Florida Department of Agriculture and Consumer Service (FDACS) registered beehive locations for reference when planning treatment operations. Larvicide operations that occur during the daytime hours do not impact bees. Adulticide operations are conducted after sunset and before sunrise when bees are in their hives to reduce risk of exposure.
