## **Airport operations**

The Airport is preparing for the 2020 Daytona 500. This includes planning meetings with the airlines (American and Delta), the Speedway and the three fixed-based operators (ATP, Sheltair and Yelvington). Traditionally, the Daytona 500 brings approximately 300 additional transient aircraft to the airport of which about 100 will need overnight parking. To accommodate this demand, the airport's crosswind (secondary) runway is closed for aircraft parking.

ARFF, VSO and Airport Control will remain open 24/7 through the Thanksgiving holiday. Airport Operations and Maintenance staff will maintain their 4 -12 a.m. daily schedule. A reduced air carrier schedule is expected on Thanksgiving Day with the final Delta arrival at 4:55 p.m. as opposed to midnight.

#### Coastal


