COMMUNITY SERVICES

Community Assistance: Community Assistance is accepting applications for Disaster Recovery Program – Relocation Assistance for income-eligible residents who have been displaced due to Hurricanes Ian or Nicole. The program is funded by the State Housing Initiatives Partnership (SHIP) and can assist homeowners and renters from a property in Volusia County but not within the city limits of Daytona Beach or Deltona. Eligible applicants may receive help with security deposits, first and last month's rent and up to three months of rental assistance. Applicants will need to provide documentation of income, proof of displacement by a Hurricane, an application package, proof of insurance and a FEMA application, if applicable. Environmental Management: Environmental Management staff recently attended Indian River Lagoon (IRL) Council meetings in Grant-Valkaria and Sebastian. The Management Board and the



STEM committees discussed seagrass, wastewater treatment plant relocations, new sources of funding and the Kennedy Space Center Master Plan. Water Quality staff sampled the IRL and its tributaries, including a new site in the southern part of the lagoon. Preliminary data indicated normal conditions in the IRL with no indications of an algal bloom. PUBLIC WORKS

Coastal: Coastal staff is diligently working to repair and re-open assets damaged by Hurricane Nicole. This includes assessing structural integrity, removing compromised sections of decking, repairing and/or replacing damaged stair treads and stringers, adding extensions and x-bracing to pilings for structural support, replacing any damaged top caps and/or side rails, aluminum railing and other repairs as necessary.

Coastal tradesworkers completed repairs to walkover three and began work on the remaining damaged sections of walkovers one and two at Lighthouse Point Park in Ponce inlet. This included



cutting back the structures to improve structural integrity and coordinating with contractors on debris removal for staff to begin the installation of new stair sets in the following weeks.

Mosquito Control: The division is sending a representative to the UF/IFAS Mosquito BEACONS working group meeting on Dec. 6. The Mosquito Biodiversity Enhancement and Control of Non-native Species (BEACONS) working group has members from Louisiana, Mississippi, Georgia, Florida, North Carolina and South Carolina. The group consists of academic researchers, mosquito control personnel and senior management, private pest control, state public health and agriculture entities and the Centers for Disease Control and Prevention. This meeting will provide advanced identification training on emerging and invasive mosquito species in the southern region. As part of an integrated pest management program, the division conducts surveillance of mosquito species throughout the County to plan field operations, and accurate identification is necessary to understand the risk of disease transmission to communities.
