Aviation and Economic Resources

Daytona Beach International Airport (DBIA)

-10/18 - American Airlines is expanding service. Beginning in January 2020, American will replace some smaller, regional planes to the mainline Airbus a319 for one of its daily flights to and from Daytona Beach to Charlotte, North Carolina. Also starting in January, American will increase the number of daily flights from four to five to Charlotte. Beginning Jan. 11, American Airlines will continue non-stop service between DAB and LaGuardia Airport (LGA) in New York.

The Airport Terminal Updates project is making significant progress as our contractor is moving forward on several fronts. Most recently the balcony area, baggage claim area, gate two, and ticket counters have all undergone significant changes.

-11/1- The airport underwent its annual Part 139 Safety/Certification Inspection Oct. 21 - 23. Part 139 is the Federal airport certification regulation that established certification requirements for airports serving scheduled air carrier operations. The inspection process is a very detailed three-day event that covers all compliance items found in 14 CFR Part 139 (the air carrier operation regulation).

The Inspector noted that DAB is a very safe airport. He also noted a very professional staff and clean, well-maintained airfield. There were several minor findings that have since been corrected or are scheduled for correction in the near future. The airport continues to maintain its very important FAA Part 139 operating certificate.

Florida Department of Health in Volusia County (FDOH-Volusia)

-10/18-Urgent dental needs of children are the subject of a quality improvement project. The DOH-Volusia recently completed a quality improvement project in six public schools to increase the low numbers of parents who attend to their child's urgent care needs following notification from the department's school-based dental team.

10-25-As of Oct. 21, 259 cases of Hepatitis A have been confirmed in Volusia County this calendar year. In all of 2018, five Hepatitis A cases were confirmed in the county. The Volusia County Health Department (CHD) continues to focus on reaching three high-risk populations by offering vaccinations and prevention education.

Influenza activity remained at low levels across Florida according to the Oct. 12 Florida Flu Review surveillance report.

Mosquito Control

10/18-Mosquito Control is actively treating for mosquitoes and advising residents to use personal protection to prevent mosquito bites in accordance with the Florida Department of Health issuing a Mosquito-borne illness advisory for West Nile virus.

10/25-The surveillance program indicates an increase in mosquito populations throughout the County following last week's rain event. We are working to schedule treatments based on surveillance data and areas of concern for Halloween related events.

Road & Bridge

10/18-On Oct. 4, work was recently completed on the Josephine Street Sidewalk project in New Smyrna Beach. The project replaced approximately 2,180 feet of sidewalk along the north side of Josephine Street from Old Mission Road to New Smyrna Beach High School. The \$80,487 project complies with the American with Disabilities Act and was funded by a Community Development Block Grant.





10/25-The Road & Bridge Tree Crew removed several hazardous trees and vegetation within the right-of-way at various locations throughout the County to include Daytona Beach, DeLand, New Smyrna Beach, Oak Hill, Ormond Beach, and Pierson. The trees were removed based on citizen requests and after Road & Bridge staff determined that the trees were hazardous.

11/1- The Road & Bridge Traffic Operations staff coordinated the approval of three lane closures and three road closures for upcoming projects in Cassadaga, Daytona Beach, Deltona, Holly Hill, Ormond Beach, and Pierson. The lane closures and road closures provide safety in the work zone for traveling motorists and workers during projects such as turn lane construction, traffic signal and cabinet replacement, railroad crossing reconstruction, and utility work. Road & Bridge staff provides advanced notice to the public and affected agencies such as public safety, law enforcement, school board, news media, municipalities, and county departments of the closure locations and dates.

Additionally, the Coastal Woods "Parent Tract" (all phases) TIA was received and processed for internal review.

10/18-Utilities staff participated in a Department of Environmental Protection (DEP) workshop promoting clean water loans and grant opportunities for nonpoint source (stormwater) pollution and sewer conversion projects. DEP officials presented various projects eligible for funding. Protection of our water resources is among the state's highest priorities for ensuring safe water quality and a reliable supply.

10/25-Performed final plan review for construction of three miles of a wastewater force main connecting the Del North wastewater facility to the Southwest Regional Water Reclamation Facility. This connection will allow for the decommissioning of the Del North facility while providing advanced wastewater treatment to a larger number of residents in Southwest Volusia. The project is expected to commence in early FY 2020.

11/1- Participated with City of DeLand Utilities on the Oct. 22 Volusia Today radio broadcast discussing regional cooperative efforts among local governments to protect water quality and limited groundwater supply. Discussed the value of water in terms of health, quality of life and our local economy.
