Environmental Management: Environmental Management staff attended a webinar related to a new state law that requires construction projects with any state financing (including grant funding), that occur within a designated coastal building zone, to complete a Sea Level Impact Projection (SLIP) Study (effective July 1, 2020). The Department of Environmental Protection has developed a web tool (floridadep-slip.org) to help local governments comply with this requirement. The tool identifies the sea level rise and increased storm risk for the project, as well as the average chance of flood damage, and the potential public safety and environmental impacts of the project. The tool also provides information about potential adaptations that can reduce the vulnerability of the project.

OCEAN CENTER

Events: The Ocean Center will host the annual Central Florida Geographical Information Systems (CFGIS) Workshop Sept. 12-15. The program includes technical sessions from Esri, user presentations, vendor exhibits, map gallery and app exhibit. We are expecting 200 attendees for this 3-day even. This is a private event. Emergency Management: The Emergency Management Team continues to participate with healthcare partners in COVID-19 vaccine related conference calls three times weekly. The monoclonal antibody infusion-testing site active in Ormond Beach has conducted the treatment to a total of 2,176 patients in Volusia County. Road & Bridge: Notice to proceed has been issued for a task assignment to review the adopted Total Maximum Daily Loads (TMDLs) for the Spruce Creek and the Tomoka River. Since the finalization of these TMDLs in 2008 and 2013, respectively, the Florida Department of Environmental Protection (FDEP) has updated Florida's criteria regarding dissolved oxygen and bacteria and adopted statewide water quality numeric nutrient criteria. Traffic Engineering / Engineering & Construction: County staff held a meeting with several homeowner associations regarding the planned improvements at the intersection of Pioneer Trail and Sugar Mill Drive. No additional right-of-way will be required and planned improvements include the following: (1) Adding left-turn lanes to all approaches, (2) Adding an eastbound right-turn lane, (3) Upgrading the multi-way stop with flashing beacon to a full traffic signal, and (4) The possible removal of some trees to ensure an adequate safety recovery area (i.e. clear zone). A sizable group of homeowners was able to ask detailed questions about the intersection project.
