Affordable Housing Initiative update. In addition to the Sept. 10 plenary webinar, staff has scheduled another webinar for Oct. 1, titled, *Getting the Right Tool for the Right Job*. There is a demonstrated need for local governments to balance the implementation of land development regulations, including zoning, with creating partnerships or incentives for affordable housing. Corrections: Corrections continues to offer COVID-19 vaccines to inmates through a partnership with Family Health Source. 1,165 Johnson & Johnson vaccinations have been administered since April. Patient Services Coordinator Dee Kaye, has successfully achieved certification as a Certified Correctional Health Professional (CCHP), a significant achievement. Staff is working with Family Health Source to develop a continuum of care for HIV inmates to receive medical care and medication post incarceration. Daniel Sullivan has accepted the position of Corrections Warden and will begin on Sept. 13. Mr. Sullivan has over 30 years' experience in the New York prison system and with private correctional institutions throughout the United States. Sullivan replaces Warden Rodney Prince who will retire on Sept. 3 with 27 years of dedicated service. In its three weeks of operation, Chief Judge James Clayton's virtual courtroom has produced considerable results toward reducing the inmate population.
