GROWTH & RESOURCE MANAGEMENT

Environmental Management: Water quality staff completed water sampling in the Indian River and Mosquito Lagoon. Chlorophyll levels are well below any indication of an algae bloom. Much dolphin activity was observed as well as migratory birds such as white pelicans and loons that are here for the winter. Environmental Permitting (EP) year-to-date inspection numbers are up 36.2% compared to this time last year. EP staff has conducted 3,103 Inspections and reviews this fiscal year. In FY 20-21, EP staff conducted 18,005 inspections and reviews, an increase of 40% over the FY 19-20. EP inspections have increased by 97% since FY 16-17.
