COMMUNITY SERVICES

Resource Stewardship: The ECHO advisory committee met on Dec. 2 to review and score the 2020/2021 ECHO grant applications. Eight of the nine applications received a score of 80 or above and will be recommended to County Council for final review and approval. Staff continue to review Volusia Forever (VF) applications and the VF advisory committee will meet on Jan. 26 to identify properties that are eligible for further consideration. FINANCE

Information Technology: Staff installed a patch to the enterprise financial system, so that 1099 forms can be processed with the latest legislative updates. Staff developed an internal-use GIS portal, leveraging the power of Active Directory to provide a new, more secure, GIS environment for county employees. Staff confirmed and converted into GIS shapes a series of new legal descriptions resulting from the decennial redistricting effort (pending official County Council adoption on Dec. 14). GROWTH & RESOURCE MANAGEMENT

Environmental Management: The Marine Science Center staff transported 58 sea turtle hatchings to Gumbo Limbo Nature Center where they were taken out to the Gulf Stream for release. On Dec. 6-7, staff also released five juvenile green sea turtles.

Members of the Volusia County Marine Mammal Stranding team helped release a manatee on Nov. 30 at Blue Spring. He was rescued in April and treated at the Jacksonville Zoo Manatee Rehabilitation Facility. On Dec. 2, the stranding team also helped rescue an orphaned manatee calf, which is now being treated for malnutrition and a skin condition at the SeaWorld Rehabilitation Facility. The stranding team coordinators will also attend the annual FWC Manatee Captures and Health Assessments to determine baseline health information of West Indian Manatees.

On Dec. 10, staff participated in the Florida Shorebird Alliance Partnership, assisting FWC with a cleanup effort of the Port Orange Critical Wildlife Area in anticipation of the 2022 nesting season.

PUBLIC WORKS

Coastal: Work is set to begin on replacement of the 27th Avenue beach ramp in New Smyrna Beach. The existing ramp structure has exceeded its life expectancy and beach erosion at the eastern end of the structure often creates a drop-off that makes the ramp unusable to vehicles. The Coastal Division has removed the gates and toll booth from the existing beach ramp and the County's Contractors started work on Dec. 8. The beach ramp will be closed to all vehicles and pedestrians during construction, which is expected to last approximately six months. During that time, vehicles are advised to access the beach using the 3rd Avenue beach ramp located approximately 1.5 miles north of 27 Avenue. The Crawford Road Beach Ramp will also now be open 7 days a week beginning Dec. 8 to accommodate the closure at the 27 Ave Beach Ramp. Mosquito Control: Staff received and setup the budgeted FY 22 capital outlay compound microscope (pictured at right). Mosquito specimens are routinely verified to species using stereo and compound microscopes depending on the specimen features required to confirm identification. Dichotomous keys are used to review anatomical features such as the placement of setae (tiny hairs), shapes and patterns of scales, and colorations. Correct identification is an integral part of mosquito surveillance as a component of an integrated pest management program.
