Community Services

Agriculture Extension (AG Center)

- Family Nutrition Program (FNP) has been providing nutrition education to council on aging locations in Volusia County, Orange City and New Smyrna Beach. FNP recently met with the council on aging to see how we can partner to have more of an impact at these sites.
- The FNP is currently getting prepared for the upcoming school year. Last week, FNP staff met with the
 master gardeners who will be volunteering in the school gardens for the upcoming year. The well attended
 meeting focused on creating sustainable gardens at the school with some gardeners, sharing success stories
 and others stories of failure.
- Seventy-five youth attended the Animal Science Workshop Series last week (Monday- Saturday). Guest speakers included UF faculty, volunteers and youth.



- The Animal Technical Rescue Branch director for the University of Florida Veterinary Emergency Treatment Service, in collaboration with the Volusia County Fire Department (VCFD) Special Operations Unit 533, demonstrated to youth how they rescue large animals. They also learned how to tie knots and use some of the equipment.
- AdventHealth Orange City community garden committee met to discuss August construction plans.
- The agent and eight master gardeners travelled and attended the "Grape Field Day" at the UF/IFAS Plant Science and Research facility.
- Eight master gardeners and the Family Nutrition Program manager discussed plans for the 12 school gardens (2019-2020).
- A Comprehensive Landscape Improvement Project Committee met in Gainesville regarding Victoria Park
 Development. Florida Friendly Landscape and low-impact development practices, their effects on
 stormwater runoff and water quality were discussed. The research project will study the effects of various
 short and long-term practices such as:
 - Soil aeration.
 - o Topdressing with organic matter.
 - Littoral plantings around storm water ponds.
 - Florida Friendly Landscaping.
- Nutrient levels in stormwater ponds will be monitored. Homeowner surveys will be conducted regarding
 attitudes, fertilizer, water and pesticide use and landscape performance. Team members include UF and
 Stetson University research faculty, Stetson students, representatives from the statewide Florida Friendly
 LandscapingTM office, Volusia County Department of Environmental Management and Natural Resources,
 St. Johns River Water Management and Victoria Park.

Community Assistance

- Human Services
 - Conducted an outreach event at Cedar Oaks apartment complex where ten low-income senior citizens were able to complete and submit LIHEAP HOME Energy credit applications.
 - o The first financial literacy class via the Western Union Settlement program took place on July 12.
- Housing & Grants
 - Children and Families Program
 - Four funding applications were received for programs that will serve children and the community in fiscal year 2019/20.
 - The contingency funding is set-aside for unique public services that do not fit within established Children and Families Program service categories funded through the Request for Statement of Qualification (RSQ) process.
 - The Children and Families Advisory Board met to evaluate the applications and recommend funding to the Volusia County Council on July 9.
 - The board recommended funding all applicants, utilizing the entire \$79,567 available.
 Recommendations will be taken before County Council prior to the beginning of the fiscal year.
 - The CFAB is proposing funding to The Volusia Literacy Council, Easterseals, Healthy Communities and Food Brings Hope.
 - o Disaster Recovery Hurricane Matthew
 - A pre-proposal meeting for manufactured homes and a pre-bid for rehabilitation contractors was held.
 - The Florida Department of Economic Opportunity (DEO) conducted a "Volusia County kick-off meeting" via telephone conference on July 16.
 - DEO will conduct a site visit relating to implementing the program. The visit has is tentatively scheduled for Aug. 14.
 - Nine applications for assistance have been received.
 - o Emergency Solutions Grant



- Community Assistance is accepting applications from non-profit organizations for the implementation of an Emergency Solutions Grant for homeless prevention or rapid rehousing services.
- Applications are being accepted electronically on the Community Force website until July 31.
- o Neighborhood Stabilization Program
 - The construction of two new NSP design build homes are close to being completed.
 Once finished, the homes will be available for purchase through the NSP home purchase program for eligible households.
 - Two additional homes will be under construction within the next few months.
- Summer Camp Scholarship Program
 - The seven-week scholarship program ends on July 26.
 - During the program, total of 1,417 applications were processed and 1,342 children were offered scholarship vouchers. Of the issued vouchers, 1,114 children registered for camp with an approved provider.
 - Staff will process payments to reimburse approved providers for weeks that children with scholarship vouchers attended camp.
 - Approximately \$300,000 in scholarship payments will be made.

Florida Department of Health in Volusia County (FDOH-Volusia)

- Volusia seals records number of teeth in FY '18-19.
- In fiscal year 2018-2019, the Volusia County Health Department sealed more than 42,140 teeth in the mouths of Volusia County children.
- Those dental sealants were placed in clinical settings and during the school day through the department's school-based dental sealant program.
- The sealants were provided at no-cost to the parents or guardians.
- Every \$1 spent on a dental sealant saves \$2.38 in fillings by preventing tooth decay.
- Summit focuses on preventing child abuse and neglect.
 - Volusia County Health Department administrator Patricia Boswell attended the Child Abuse Death Review (CADR) Summit last week in Orlando.
 - Presenters shared innovative and promising prevention strategies from around the state.
 - The CADR works to eliminate preventable child abuse and neglect deaths in Florida.
 - o In 2018, the Florida surgeon general reappointed Boswell to represent the Department of Health on the local and statewide CADR committee.
- Update: Hepatitis A outreach continues to target high-risk populations
 - As of July 29, 180 cases of hepatitis A have been confirmed in Volusia County this calendar year. In all
 of 2018, five hepatitis A cases were confirmed in the county.
 - The high-risk populations are: drug users, the homeless population, and inmates at correctional institutions.

 entertainment videos from three popular library resources by connecting their device to a TV to stream or
 watch on their computer.

• Natural Resource Protection

- As of July 18, there were 794 nests on our beaches, including two Kemps ridley nests, the rarest of all sea turtle species.
- Through the end of June, the Environmental Permitting Activity has performed 9,481 permits/inspections/reviews. This is a 6.5% increase over the same time last year. In addition, they have handled 7,479 phone calls/walk-ins/emails, a 14.7% increase over last year.
- On July 13, Manatee Protection Program staff assisted Save the Manatee Club with the annual "Blue Spring State Park Cleanup".
- On July 15, Manatee Protection Program staff presented on manatees at the Ormond Discovery Center.
- On July 16, Volusia Monofilament Recovery and Recycling program collected close to 100 pounds of fishing line and marine debris during an underwater cleanup at the Ponce Inlet Jetty.
- On July 16 and 17, Volusia County Marine Mammal Stranding Team assisted the Georgia Aquarium Conservation Field Station (GACFS) with dolphin Health and Environmental Risk Assessments (HERA) research project. - The second youth conference is the Gauntlet 2019 produced by NewSpring Church out of South Carolina. This conference has about 3,700 students, with total attendee days of 11,100 and generates 3,600 room nights by the end of the week. This group also has worship services and similar fun activities, but they make exclusive use of Spectra's food services here at the Ocean Center. This is a very large catering contract.

Mosquito Control

Operations

- Field inspectors conducted surveillance and treatment of mosquito larvae by ground and boat due to large amounts of recent rainfall. Requests for service from the public increased over the last two weeks, rising from 124 (June 22 – July 5) to 201 (July 6 – July 19).
- Through continued surveillance of adult mosquito populations, staff planned and conducted targeted ultra-low volume (ULV) truck operations to treat over 39,200 acres.
- On July 14, staff larvicided over 800 acres by helicopter in the north and south salt marsh areas to treat mosquito larvae before they hatch into adults. These mosquitoes are blown inland by winds from marsh areas and will bite during the day and night.
- Crews continued to conduct routine door to door inspections of various neighborhoods, responding to service requests and educating the public while treating what the inspections found. Surveillance shows an increase in Aedes aegypti and Aedes albopictus mosquitoes which are found in common yard items such as tires, bird baths, kids toys, pet bowls, and yard ornaments. Residents are being encouraged to dump out standing water once a week to break the life cycle of these mosquitoes which can survive in containers as small as a bottle cap.



Road & Bridge

- Construction Maintenance
 - Work has begun on the Josephine Street ADA improvement project adjacent to New Smyrna Beach High School. This project consists of removing and replacing existing sidewalks, curb ramps and crosswalks in order to ensure ADA compliance. This project is partially funded with Community Development Block Grant (CDBG) funds.
 - Maintenance crews completed shoulder repairs to Airport Road in the Ormond Beach area. This work consisted of removing excess vegetation and material from along the edge of pavement to allow stormwater to properly flow off of the road into the adjacent swales and ditches.
 - Traffic operations crews installed new thermoplastic stop bars at multiple locations throughout Halifax Plantation in the Ormond Beach area.
 - Drainage maintenance crews completed the cleaning of the Gabordy Canal along 10th Street in the Edgewater area. This work consisted of removing excess vegetation and debris from the canal to ensure the proper conveyance of water through the canal.

Solid Waste

- Disposal Activities: : In the past two weeks, the Tomoka Farms Road Landfill received and processed over 15,810 tons of garbage, 5,869 tons of construction and demolition debris, and over 4,816 tons of yard waste.
- Litter Enforcement: In the past two weeks, Solid Waste Management Compliance Officers have actively
 patrolled SR 415 conducting 31 secured load inspections and issuing seven written warnings to address
 windblown litter from unsecured waste loads.
