**II CERTIFICATE OF COMPLIANCE:**

The undersigned owner of the above described property, being fully aware of the provisions of Chapter 72, Division 4, Section 611(c)(2), Chapter 72, Division 8, Section 776(c) of the Volusia Land Development Code, and Section 3307 of the Florida Building Code, as amended, hereby certifies that development of the above described property will not result in:

1. Flooding of adjacent lands.
2. Blockage of existing drainage systems, natural or manmade.
3. The destruction of existing drainage systems, natural or manmade.
4. Erosion of fill or disturbed materials onto adjacent lands or environmentally sensitive areas (as determined by the environmental control officer).
5. The destruction of roadside drainage swales, roadway pavement and/or shoulders.
6. Flooding of proposed structure during a 100-year-frequency storm or construction to an elevation less than that indicated on the Flood Insurance Rate Maps (FIRM) as are available in the Growth and Resource Management Department and at the FEMA Map Service Center: <https://msc.fema.gov/>

The undersigned hereby releases and holds harmless the County of Volusia and its authorized agents and/or employees from any and all claims of damage of every kind and nature whatsoever to said property, or contiguous properties, arising from the approval of this application or construction of required improvements.
2. The undersigned hereby grants unto authorized agents and/or employees of the County of Volusia the right to enter upon said property for inspection and enforcement activities. The County of Volusia reserves the right to require the property owner and/or permit holder to implement reasonable measures regarding drainage control during construction activities including, but not limited to, a submittal, acceptance and review of a signed & sealed engineered drainage plan or a signed acknowledgement letter indicating that the site grading will be under the direction of a Florida Registered Engineer during construction. Additionally, a certification affidavit prepared by a Florida Registered Engineer attesting that "The site has been graded properly as not to create any adverse conditions which would affect the adjacent properties" will need to be submitted, reviewed and accepted by authorized county staff prior to final project acceptance.
