

# The Indian River Lagoon Council

A Special District of the State of Florida and  
Host of the Indian River Lagoon National Estuary Program



**The Indian River Lagoon** is a diverse, shallow water estuary stretching across 40 percent of Florida's east coast from Ponce de Leon Inlet in Volusia County to the southern boundary of Martin County. The lagoon, designated as an estuary of national significance, is a critical water body in the state. For many decades, the health of the estuary has been impacted by excess nutrient pollution and freshwater flows.

**The Indian River Lagoon Council (IRL Council) & Indian River Lagoon National Estuary Program (IRLNEP)** provides a non-regulatory, stakeholder-driven, collaborative approach to coastal watershed restoration and protection. The initiative is comprised of federal, state and local citizen stakeholders dedicated to developing and implementing science-based actions to restore and maintain the natural, social and economic assets of the Indian River Lagoon.

**The IRL Council** is comprised of the United States Environmental Protection Agency, Florida Department of Environmental Protection, the St. Johns River and South Florida water management districts; Volusia, Brevard, St. Lucie and Martin counties as well as the Indian River County Lagoon Coalition. Working through the IRLNEP and its new Management Conference, the IRL Council shares the experience and expertise of representatives from business, government, academia and local communities to achieve long-term benefits and healthy, vibrant communities.

## Stewardship Goals of the IRL Council and IRL National Estuary Program:

- Sustain endangered and threatened species, fisheries, commerce and recreation by attaining and maintaining the quality of water, sediment and habitats.
- Improve management of the system by coordinating agency actions and promoting awareness, understanding and sustainable behavior among citizens.
- Restore, preserve and enhance the Indian River Lagoon by identifying and cultivating long-term funding for prioritized projects and programs.

## The IRL Council agreed unanimously to share three recommendations with Governor Scott and the Florida Legislature in 2016:

### Recommendation #1:

Support the IRL Council Interlocal Agreement by providing annual funding as proposed in the budgets of the Florida Department of Environmental Protection, St. Johns River Water Management District and South Florida Water Management District

### Recommendation #2:

Support a science-based, comprehensive and long-term program to restore and sustain the IRL

### Recommendation #3:

Request expanded federal funding for the U.S. EPA National Estuary Program, with increased funding for national estuaries with urgent needs.

## Legacy for the Indian River Lagoon

The lagoon supports a multitude of industries and activities, from fishing and recreation to tourism and agriculture. Restoration efforts are now underway.

Recent

evaluation of water quality and events indicate that the Indian River Lagoon is in need of comprehensive planning, strategic actions and a sustained investment to ensure its environmental and economic health.

The IRLNEP answers the call to action and is leading the effort to promote awareness and protect this state and national treasure.



## Quick Facts about the Five County Indian River Lagoon Region

- Nationally recognized as part of the longest barrier island system in the United States
- Occupies approximately one third of Florida's east coast
- Encompasses three water bodies: Indian River, Banana River and Mosquito lagoons
- Contains high biological diversity of plants and animals
- Home to more than 1.65 million residents
- Generates more than \$3.77 billion annually and provides 15,000+ jobs as a proven economic value for Florida
