

FINAL PUBLIC NOTICE

The Federal Emergency Management Agency (FEMA) has received the subgrant application for road repairs due to damages from Hurricane Irma (DR-4337-FL PW-6400). Pursuant to Executive Order 11988 and 44 CFR Part 9.12, final notice is hereby given of FEMA's intent to provide funding for this project under the Public Assistance (PA) Program.

An initial disaster-wide Public Notice was published on October 6, 2017 for Hurricane Irma. Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

- Location of Proposed Work:** Site 2: River Road, Oak Hill, FL (28.87367, -80.83971). Site 3: Harbor Road, Daytona Beach, FL (29.10125, -80.96895).
- Floodplain:** Site 2: Project is located in Zone AE5, otherwise known as the areas subject to inundation by the 1-percent-annual-chance flood event, per Volusia County FIRM Panel #12009C0050G, #12127C0830J dated 3/17/2014, 9/29/2017. Site 3: Project is located in Zone AE7, otherwise known as the areas subject to inundation by the 1-percent-annual-chance flood event, per Volusia County FIRM Panel #12127C0526J, #12127C0527J dated 9/29/2017.
- Proposed Work and Purpose:** Repair River and Harbor Roads to pre-disaster design, function and capacity within the existing footprint.
- Project Alternatives:** The alternative that has been considered is the no action alternative. This alternative is not feasible as the area will remain vulnerable to flood risk. With the no action alternative, continued negative impacts on social and economic resources for the community may be experienced. Alternate locations outside of the floodplain were not considered as there were no alternate roads that serve the needs of the community.
- Comments:** This will serve as the final public notice regarding the above-described action funded by the FEMA PA program.
