## Employees provide input into new health plan RFP

The county's health insurance must be renewed by Jan. 1, 2017. Before sending the solicitation for the health plan request for proposal (RFP) to vendors, County Manager **Jim Dinneen** created an Employee Benefit Team (EBT) to involve employees and get their input.

The EBT has met three times since October 2015. During those meetings members learned the current components and costs of the county's health plan so they could communicate with fellow employees and get their input for the upcoming RFP.

With the input of the EBT and their co-workers, Personnel drafted a scope of services and presented it to the County Council Dec. 17, 2015. The County Council approved it to be released in January 2016.

### Timeline for the health plan RFP

- Released in January 2016
- County Council will review it in June 2016
- New plan effective Jan. 1, 2017

### Key components of the scope of services include:

- Solicitation is for fully insured and self-insured plans
- Long-term contract (10 years)
- A single carrier
- Administrative services only (ASO) through selected carrier with experience with four or more employers, each having 3,000 or more subscribers, within the past five years
- Pharmacy and Employee Assistance Program (EAP) services through selected carrier

## Property Appraiser employees earn certifications

Eight employees of the Property Appraiser's Office recently received professional certifications, either as a Florida evaluator or cadastralist.

To earn the designations, each candidate completed four or five one-week courses with each course focusing on a different area of appraisal or mapping. These courses are sanctioned by the International Association of Assessing Officers and administered by

the Florida Department of Revenue.

It takes two to three years for all the courses to be completed because they are held at different times of the year in different Central Florida locations.

## VCSO honors 208 volunteers at annual banquet

Sheriff **Ben Johnson** recently offered thanks and praise to more than 200 attendees at the annual Volunteer Appreciation Banquet at the Ocean Center.

"I want to thank you all from the bottom of my heart," Sheriff Johnson said. "You have helped make the past 16 years the greatest 16 years of my life. What you do for this agency, and what you do for this county and its citizens, is unparalleled."

Sheriff's Office volunteers provide a wide range of administrative, clerical, professional and technical assistance. In total, 208 volunteers donated 62,416 hours of service last year for an estimated value of \$1.35 million.

Many of the volunteers were recognized for their hours or years of service at the banquet. Ten volunteers were also recognized as recipients of the President's Call to Service Award, which honors Americans who've given more than 4,000 or more hours of service.

**Sandra Carlson** was recognized as the Sheriff's Office's 2015 Volunteer of the Year. Carlson volunteers in the Sheriff's Office Deltona headquarters and has trained with civil deputies to help them with research on subjects to be served and is continuing to train on several other databases.



Before handing out the awards, Sheriff Johnson reminisced about his early days in law enforcement dating back to 1971 when there was little in the way of training, technology or back-up to help deputies get the job done. The sheriff revealed he initially didn't plan to make a career out of law enforcement. He originally was going to work and save money to attend law school. Yet the end of his current term will cap off a law enforcement career spanning more than 42 years.

"It really has been an honor being your sheriff," Sheriff Johnson said as he reinforced to the volunteers their value to the agency. "I thank you, and I know the next sheriff is going to want you just as bad as I wanted to have you."

Each year, the FCCMA selects one to three entry-level budget analysts working in local governments around the state, who aspire to become city managers or county administrators.
