Dear Sir or Madam:

According to the Volusia County Code of Ordinances every person who transports commercial solid waste and/or used tires within the unincorporated areas of the County must possess a valid transportation license regardless of location and/or ownership of solid waste disposal site.

Enclosed, please find the 2019/2020 application for the Volusia County Solid Waste Division Commercial Collection and Waste Tire Transportation License.

To ensure proper processing:

- **Make sure all spaces are complete and legible**
- **Include both copies of the application upon submission.**

(Once your application has been processed the yellow copy will act as your receipt.)

The application fee for **each** vehicle and/or trailer used for transporting commercial waste is \$10.00.

You will receive a decal to be displayed on each vehicle and/or trailer. For vehicles, please display the decal on the driver's side of the windshield in the upper corner, and for trailers display the decal on the driver's side.

To comply with the provisions of the Mandatory Commercial Compliance Solid Waste Tire Ordinance 106.165, a copy of the transportation license is required to be in the licensed vehicles at all times. All transportation licensed vehicles are subject to inspection for safety and compliance at any time or location in Volusia County by Solid Waste Compliance Officers. Failure to comply may result in a citation.
