

**SIXTY-SEVENTH EXTENSION OF STATE OF LOCAL EMERGENCY
RELATED TO CORONAVIRUS DISEASE (COVID-19)**

WHEREAS, section 252.38(3)(a)(5), Florida Statutes, provides authority for political subdivisions to declare a State of Local Emergency and to waive the procedures and formalities otherwise required of political subdivisions in order to take whatever action is necessary to ensure the health, safety, and welfare of the community;

WHEREAS, section 252.38(3)(a)(5), Florida Statutes, provides authority for political subdivisions to declare a State of Local Emergency and to waive the procedures and formalities otherwise required of political subdivisions in order to take whatever action is necessary to ensure the health, safety, and welfare of the community; and

WHEREAS, Chapter 252 of the Florida Statutes limits the duration of each State of Local Emergency to seven (7) days and it may be extended, as necessary, for additional terms in seven (7) day increments.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF VOLUSIA COUNTY, FLORIDA, IN OPEN MEETING DULY ASSEMBLED IN THE COUNCIL CHAMBERS OF THE THOMAS C. KELLY ADMINISTRATION CENTER, 123 WEST INDIANA AVENUE, DELAND, FLORIDA, THIS 22ND DAY OF JUNE, 2021 A.D., AS FOLLOWS:

SECTION I: That the effects of COVID-19 continue to pose a serious threat to the health, safety, and welfare of the residents of Volusia County and that an extension of a State of Local Emergency is declared, effective immediately throughout Volusia County, Florida.

SECTION II: The Declaration of State of Local Emergency issued on March 13, 2020, and subsequently extended thereafter, is hereby extended effective as of 5:00

p.m., June 22, 2021 for an additional period of seven (7) days to 4:59 p.m.,
June 29, 2021.
