Belvedere Terminal Company, LLC (Belvedere) is proposing to construct a greenfield refined products terminal in Ormond Beach, FL (Ormond Beach Terminal). Quadratic Consulting, LLC (Quadratic Consulting) is providing a review of the air construction permit application, the air construction permit issued, and the public notice for content and accuracy for the Ormond Beach Terminal.

Air Construction Permit

An air construction permit application was submitted on March 02, 2023, for the construction of the Ormond Beach Terminal in Volusia County. The application included a thorough evaluation of the potential air emission estimates from the facility based on the proposed emission sources. The facility is classified as a minor source since it is below 100 tons per year (tpy) for any air pollutants, and below 10 tpy for any single hazardous air pollutants (HAP), and 25 tpy for any combination of HAP.

A comprehensive analysis of applicable federal and state regulations was included in the air construction permit application. The analysis discussed several federal and state regulations the facility and/or emission source was subject to. These applicable federal and state requirements are reflected in the air construction permit issued by the Florida Department of Environmental Protection (FDEP).

Public Notice

A public notice is required to be published prior to the issuance of an air construction permit in accordance with 62-210.350, F.A.C. The public notice must be published in accordance with the applicable provisions of Rule 62-110.106, F.A.C. The Ormond Beach Terminal was subject to 62-110.106(5), F.A.C., which requires the person publishing a notice shall do so at his own expense in the legal advertisement sections of a newspaper of general circulation (i.e., one that meets the

requirements of Sections 50.011 and 50.031, F.S.) in the county or counties in which the activity will take place or the effects of the Department's proposed action will occur, and shall provide proof of publication to the Department within seven days of the publication.

Belvedere published a public notice in the Hometown News Media Group – Ormond Beach newspaper on July 7, 2023. The Hometown News Media Group newspaper meets the requirements of 50.011, F.A.C., as it publishes once a week and contains at least 25 percent of its words in the English language. This newspaper is readily available to the public and distributed throughout Daytona Beach, Holly Hill, Ormond Beach, and surrounding areas with more than 10 publicly accessible outlets. The newspaper has been in existence for more than 2 years and meets the requirements of 50.011, F.S., therefore the newspaper meets the requirements of 50.031, F.S.

FDEP received the proof of publication on July 13, 2023, which is within the seven days of the publication requirement.

Closing

In my professional opinion, Belvedere submitted a complete air construction permit application and met applicable FDEP requirements for obtaining an air construction permit. The public notice requirements, as provided in 62-210.106, F.A.C., were also met with the publication in the Hometown News Media Group – Ormand Beach.
