



DECLARED DANGEROUS DOG LIST

The dogs listed on this site have been declared dangerous by Volusia County Animal Services.

GUIDELINES USED IN DETERMINING A DANGEROUS DOG

- The dog has, without provocation, aggressively bitten, attacked, or endangered a human being, or has inflicted severe injury on a human being on public or private property; or
 - Has more than once, without provocation, severely injured or killed a domestic animal while off the owner's property; or
 - Has been used primarily, or in part, for the purpose of fighting, or is a dog trained for dog fighting; or
 - Has, without provocation, chased or approached a person upon the streets, sidewalks, or any public grounds in an aggressive, menacing fashion or apparent attitude of attack, provided that such actions are attested to in a sworn statement by one or more persons, and dutifully investigated by the appropriate authority.
- A dog shall not be declared dangerous if the threat, injury, or damage was sustained by a person who, at the time, was unlawfully on the property, or while lawfully on the property, was teasing, tormenting, abusing, or assaulting the dog or its owner or a family member.
- No dog may be declared dangerous if the dog was protecting or defending a human being within the immediate vicinity of the dog from an unjustified attack or assault.

If Animal Services finds sufficient cause to declare a dog "dangerous," the owner is notified in writing. At this point the owner has three options:

1. Appeal the notice of sufficient cause to Volusia County Animal Services, which will hold a hearing before the Hearing Officer and either accept or rescind the declaration. If the Hearing Officer accepts the sufficient cause findings, the owner may appeal their decision to the County Court.
2. Comply with the Dangerous Dog Restrictions (listed below).
3. Surrender the dog to Animal Services.

COMPLYING WITH THE DANGEROUS DOG RESTRICTIONS

To comply with the restrictions, a dog owner must obtain a **certificate of registration** for the dog from the Animal Services Division. The dog owner must obtain this certificate within 14 days after issuance of the final order classifying the dog as dangerous or the conclusion of any appeal that affirms such final order. The initial registration fee for the dangerous dog shall be \$1,500. The owner shall be required to renew the certificate at an annual cost of \$500.

To obtain a certificate of registration or a renewal thereof, the owner shall be at least 18 years old and present to the Animal Services Division sufficient evidence of:

- **Current certificate of rabies vaccination** for the dog

- **Proper enclosure** to confine a dangerous dog as defined in section 14-42(b)(3)
- **Clearly visible warning sign** that informs the public of the presence of a dangerous dog on the property, measures at least 8 1/2" x 11," and is conspicuously placed at all entry points
- **Permanent identification** of the dog, such as a tattoo on the inside thigh or electronic implantation
- **Spay/neuter certificate** from a veterinarian
- **Proof of liability insurance** for the premises where the dangerous dog shall be securely enclosed

If applicable, a **notarized statement** shall be submitted to the Animal Services Division by the landlord of the dog owner's premises where the dangerous dog shall be securely enclosed, including a statement confirming that the landlord shall adhere to all posting regulations and insurance requirements.
